

Bread subsidy to be distributed next week

s early as next week the Ministry of Agriculture, Food Security, and Enterprise will be distributing the first portion of its promised subsidiary to several bakers across the country to assist them to alleviate operational expenses due to the high cost of wheat on the international market.

Late on Thursday evening, The Reporter spoke to Lennox Nicholson, the controller of supplies in the Ministry who indicated, "As we speak, the resources have been disbursed to the Ministry of Agriculture, Food Security and Enterprises by the Ministry of Finance. So those resources are within our Ministry and we can start drawing down


MOE: 'School policy cannot trump students' right to education'

at the beginning of the month," Alvarado told The Reporter on Thursday.

While he said that the amount varies individually depending on the amount of fuel consumed per month as well as the number of passengers, Alvarado said that with the rising cost of fuel, any assistance rendered is welcomed and appreciated by stakeholders. This, according to Alvarado, is because tour operators need to come together and put in places standardized prices." Alvarado also revealed that while the fuel subsidy might only be seen as slight assistance, the BTB currently has several other programs available for tour operators to tap into. One of those includes a duty exemption on goods, equipment, ATVs, and even vehicles into the country.

equipments used in Tourism, so examples include vans, boats, engines, gears, etc."

"I could personally tell you that all this wasn't being done before, because two years ago I tried to apply for duty exemption for a vehicle and equipment," said Alvarado. "I was not approved because they told me that it was only for the bigger companies. Now with this new BTB administration, small people are really benefitting from it. I, for example, have just bought a new tour van with duty exemption, we formed a partnership, and we got ATVs with duty exemption, and snorkeling gears with duty exemption, so it is working and they are working. Like I said every help that is given to the local operators is very much appreciated." But while the fuel subsidy has eased the burden on their pockets, Alvarado said that with the prices of fuel falling on the international market, he would like to see fuel prices, as well as the cost of living, also plunge in Belize.

Alvarado is now calling for a set price structure for tour operators and even tour guides to be put in place so that when fuel prices fluctuate on the international market, the price structure locally can be adjusted automatically. He registered and up to date with taxes, social security payments, and other relevant documentation and certificates so that they too can benefit from programs.

Close to 200 licensed tour and tender operators are currently benefitting from the BTB's fuel subsidy program that was rolled out in early July to alleviate operational expenses, due to the rising cost of fuel.

This week Russia announced a recruitment drive to raise 180,000 new troops for its depleted army.

on those resources to make payments to the bakers. A form has also been sent out to the bakeries to submit to us their claims along with supporting documents, invoices, and things of that nature to facilitate the payments."

Nicholson confirmed that in this instance only eight bakeries, who have sent in their application and were properly vetted and approved, will be receiving payments for June and July. He said that one other bakery is pending but that the Ministry is in the process of querying additional information from the particular bakery before proceeding with payments.

While Nicholson indicated that the Ministry had conducted a comprehensive study of bakeries in the country, and 26 of them were found, not all of them had qualified for the subsidy, while several others have not applied for the assistance, which currently stands at \$1.5 million.

"Going forward now I must tell you that there are a couple of enterprises that are noticeably absent from the list.

"We know that in at least a couple of these instances they do produce the 16-ounce slice of bread and would be eligible for the subsidy. We will be sending an officer to visit these folks to explain to them that the program is there and that some relief is available to them under the program. We will encourage them to submit their documentation so that we can provide the necessary assistance," indicated Nicholson.

He added that while it was initially agreed that the assistance would have been rolled out in June and July, some administrative matters needed to be attended to. That, according Nicholson, t o included compiling a comprehensive list of enterprises in the bread industry

and then ensuring that they met the requirements for enrolling in the program, by conducting field visits. Those field visits also allowed the Ministry to explain to the bakeries that only 16-ounce slices of bread would be covered by the program. It also allowed the Ministry gather the to required data, such as the volume of the regulated products that they produce, the estimate, and the invoice to indicate how many sacks of flour they used every month to produce a 16-ounce slice of bread.

That data was then used to calculate how many funds needed to be disbursed and to work out a payment formula.

"For instance, it is 25 cents per pack. The flour that is used to produce 16-ounce slice bread is Bebe Agua, so when the submission comes into us, the key indicators that we look at is how many sacks of Bebe Agua flour the particular



enterprise use in a given month. Based on the submission that was made to us by the bakers there is a ratio of 120 packs of bread per sack. So if you multiply that by 25 cents then you would get an idea for every sack of Bebe Agua flour that they use how much money would be disbursed to them. Based on the agreed interaction with them we came up with another. The Formula says that out of a sack of flour they would

use an average of 70% of that to make 16 oz slice. So if a particular entity would use 1,000 sacks of flour per month we would only pay them for 700 bags. And using the rate of 25 cents per pack and one sack yielding 120 packs, it works out somewhere in the area of \$30 per sack," explained Nicholson.

We also asked him about the continuous decrease of wheat prices on the international market and if he expects that price decrease to reflect locally. While Nicholson said yes, he claimed that a key factor in that scenario will be timing based on the trading pattern. He stressed that the price changes will not be reflected until that particular shipment lands in the country. When that occurs Nicholson said that the job of his office will be to ensure that those prices are reflected domestically.

Tuesday, after being told that their hair was too long and in contravention of the school policy.

After being briefed on the situation, the Ministry of Education, Culture, Science, and Technology (MoECST) issued a statement saying that it was sincerely concerned about students being denied their education over such a policy, stressing that the act has violated two of the students' constitutional rights.

"The Constitution enshrines the principles of social justice and clearly states in its preamble that 'equal protection should be given to children regardless of their social status, and that a just system should be ensured to provide for education and health on the basis of equality.' Furthermore, the rights to freedom of expression, conscience, and the right to be protected from discrimination are afforded to all Belizeans by our Constitution," the Ministry said. While the ministry conceded that schools do have the freedom to enact policies and general rules for codes of conduct, these rules must not infringe upon students' rights. The ministry also noted that students need as much in-class time as possible, having been out of school for an extended period due to the COVID-19 pandemic.

"We call on all our partners to continue to work with the ministry to build a more equitable, accessible, and inclusive education system, through which all students are guaranteed the opportunity to acquire knowledge and skills to build a better life for themselves and contribute to Belize's national development," the Ministry added.

Notably, the students reportedly returned to classes on Thursday, with their hair cut to suit the school policy. The situation has sparked public outrage and debate, with many condemning the school and categorizing the haircut and similar policies as "archaic" and "symbols of oppression". Advocates against policies t h e emphasize that it disproportionately affects male students, as well as students of certain ethnicities. Alternatively, some have embraced the rules, stressing that the students and their parents were well aware of the rules and agreed to follow them when they sent the students to that school. Supporters

of the rules contend that the issue extends far beyond the issue of the length of the student's hair and into their ability to respect authority and become law-abiding citizens outside of academic settings.

The issue of hair discrimination in Belize is an active one, as incidents such as the one at Bishop Martin have been brought to the media by different schools every school year in recent years, such as the 2018 incident at Nazarene Highs School in Belize City.

Beyond academic settings, hair discrimination in the work place was underscored by the 2019 lawsuit of eight female police officers, who filed a lawsuit against the Belize Police Department for imposing disciplinary measures on them because they decided to grow dreadlocks. The Commissioner of Police explained at that time that there was a practical element to the police policy on hair, as longer hairstyles could be used against a police officer trying to detain a resisting suspect. In 2021, the Supreme Court would rule that such actions were against the officers' constitutional right of expression.

Leave No One Behind - MoECST

"Leave no one behind" is the key pillar of the Ministry of Education's program of inclusion to empower Belizean children with the job skills and the life skills to develop Belize's economy in the 21st century.

Minister of Education, Culture, Science and Technology Hon. Francis Fonseca outlined how it will work, when he launched the BES plan 2.0 at the Best Western Belize Biltmore Plaza Hotel in Belize City on Monday morning, August 29.


The plan extends far outside the classroom, and the ministry is partnering with other ministries and other interested parties in the community to put the plan into action, Minister Fonseca explained. The health ministry is supporting the plan with its vaccination program and counseling to safeguard the students' mental health.

Students need not worry about their personal safety, as the Police Department is plugged in to provide security for the schools. The Transport Department is tasked with ensuring that the students have adequate means to get to and from school. The four-pronged plan is to reform the education system, to transform how students learn from how they are taught, to give priority to sectors which have been underserved. and to make the best and maximum use of our human resources, as Chief Executive Officer Dian Castillo Maheia explained by a video presentation. Free tuition, free uniforms, free meals and computer access for students from lowincome families are the main features of the **Education Upliftment**

Project, which is rolling out the plan to four government high schools in Belize City's southside when schools opened last week: Gwen Lizarraga High, Sadie Vernon Tech, Excelsior High and Maud Williams, as Sadie Vernon principal Deborah Martin explained. The objective is to build better citizens for better families and a stronger, more skilled and productive work force. The project is in

Students cannot learn if they are under-nourished, so the "Healthy Start' Feeding program is an essential part of the plan, Chief Education Officer Yolanda Gongora explained. Children who come to school hungry have difficulty learning, because they can't focus on anything beyond the emptiness in their tummies, and this can hurt enrollment. The ministry is working to guarantee that schoolchildren are adequately fed by expanding the schools feeding program with a parallel schools garden project. The initial pilot phase is being funded by the United Nations' Food and Agriculture Organization (FAO) and the Mexican Agency for Cooperation in **Economic Development** (AMEXCID) has targeted six primary schools, two each in the Corozal, Orange Walk and Belize districts. The Government of Taiwan has provided additional funds to help to extend the program to other schools throughout the country. Another top priority is Special Education for children with special needs, as consultant Christy Almeida explained. An occupational therapist, a certified behavioral analyst and a speech and language pathologist are now working with the ministry to support these children's development. Internet connectivity is no longer optional, it's become an absolutely essential, Fonseca emphasized. The Ministry is also partnering with Digi in the "ConnectED" project to bridge the digital divide, to ensure that students can access the information superhighway of the Internet. Digi is installing the fiberoptic infrastructure to ensure that all schools in the country have broadband Internet access, so that students may have Wifi connectivity anywhere on campus. This means offering Internet connectivity in even the remotest areas.

Minister of State Hon. Dr. Louis Zabaneh outlined how the ministry has created the 501 Academy as an online portal, where teachers can access teaching materials and resources to help them prepare their lessons, and students can access lessons for Open Education via the internet. The aim is to excite the students in the classroom, to entertain their interest and encourage them to

The **Government of Belize (GOBZ)** through the **Ministry of Infrastructure Development and Housing (MIDH)** invites contractors who are interested in carrying out road and drainage restoration works in three districts in Belize, namely, Belize, Orange Walk and Corozal Districts affected by the tropical wave on August 17-18, 2022. Restoration works proposed in all three districts will vary but will include drainage improvement works with culvert installation; resurfacing of roads and paving of a few roads.

Interested contractors are encouraged to register and submit requested prequalification information which the MIDH will evaluate based on a set criterion. Based on the findings of the evaluation, contractors will be prequalified for the various types of road restoration works proposed to be funded with the Emergency Funds.

Contractors are informed that the proposed works are of an emergency nature and therefore the time period for submission of the requested information will not exceed more than seven (7) calendar days. It is expected that the prequalification exercise will provide for easier selection of reliable contractors based on satisfying minimum criteria of each of the identified categories and sub-categories.

Contractors will be categorized by size and experience and are hereby invited to register under one or more of the following categories as may be applicable:

- I. Civil Works / Road Construction capable of executing works associated with road construction and other major infrastructure developments such as land clearing, earthworks, drainage, flexible and rigid pavements, road markings and road furniture installation, and structural concrete.

The ministry is also working to help teachers transition to the new curriculum which was launched two weeks ago. CEO Yolanda Gongora explained that the ministry has teams of the best teachers from around the country working together to create lesson plans that other teachers can download and use as a template, and tweak to suit the needs of their students. The first set of lesson plans for the first month of school is already online, and the teams will be uploading new modules of lesson plans in the coming months.

Concerns for Carnival Following Public Shooting at Mass Camp

The countdown to the return of the 2022 annual Carnival Road March, which is scheduled to be held this Saturday in Belize City has commenced, however, there are already concerns for the safety of the public as well as revelers following a public shooting that took place at Mass Camp, this past Tuesday night. On Wednesday, during a virtual briefing with the Commissioner of Police Chester Williams he admitted that the shooting which resulted in injuries to a student, the detention of a suspect, and the recovery of a firearm was certainly a cause for concern.

Williams said that while he has already

seen comments on social media in which persons are expressing their concerns for safety and even going as far as to say that they will not attend the event he wanted to assure the public that the Belize Police Department will be on the ground in full force. According to Williams, multiple teams will be in a position in full readiness to ensure the safety of all persons on the ground who will either be participating in the road march or those that will be watching from the sidelines.

The Commissioner also addressed growing requests and complaints from the public that the Police Department s h o u l d h a v e extended the State of Emergency in the Lake Independence





n e i g h b o r h o o d instead of allowing it to be lifted on Monday. These requests come on the heels of the most recent shooting which had transpired in the midst of revelers who had come together to show off their costumes. Williams, however, indicated that the persons who were involved in that act of violence were not members of the Lake I neighborhood who were detained under the state of emergency.

In fact, he said that they were members of the Antelope Street Extension, which has been known to be problematic in the past. This is an area where Williams said that he is also considering rolling out a State of Emergency if the violence does not subside.

As it related to the 30 gang members that were released from the Belize Central Prison on Monday, Commissioner Williams said that prior to them being released back into the public, a meeting was held between them, the LIU, the BPD, and several other agencies to examine their state of readiness.

"We are optimistic that they are going to hold their corner, at least for now and I had said to the officer who had attended the meeting with them to convey my message to them that even though they are being released now if it is that they would want to start their foolishness again I will be more than happy to go back to the Minister and the Prime Minister and request that they be sent back to the prison. And if that were to happen then it would certainly be more than 30 days," explained Williams.



CPL Nah and PC Caliz Cleared of Internal Charges for Ammunitions

⊂orporal Elmer Nah and PC Manuel Caliz have both been found not guilty by a Police Tribunal and have been cleared of all internal charges in relation to several pieces of ammunition that were reportedly found in their possession during the November 2021 drug plane bust that occurred near Bladen Village, Toledo District.

On Wednesday, the Commissioner of Police Chester Williams held a virtual briefing with the media in which he confirmed the reports that the police adjudicator had indeed issued a "not guilty" verdict against both officers on Tuesday of this week. Williams further reiterated that because the

ammunition were reportedly found in a vehicle that both officers were in at the time, he was not expecting the outcome of the tribunal and was even "disappointed" in it.

"I was further briefed that that came because of a testimony that was given by another officer that he had signed for those ammunitions and that he had left them in the vehicle. But again looking at the circumstances that the officer who testified to the effect that he had left the ammunitions inside the vehicle, the vehicle in question that he had supposedly left the ammunitions inside is not the same vehicle that the two gentlemen were found in, and

at the time had the ammunitions in it. So I still cannot understand on what basis the adjudicator decided that these two gentlemen were not guilty," said Williams as he went

on to question how the ammunitions ended up in the officer's vehicle.

Williams said that he has since requested that the files and the notes of evidence be sent to his office so that he can personally review them or have a legal team pour over them to see whether or not the adjudicator had erred in his decision to acquit both men. Given that the Commissioner of Police has the authority to either uphold the decision or overturn it, Williams promised that he will be doing all in his power to investigate the



ruling. That includes looking at the testimony that was given by the officer who had claimed responsibility for the ammunition and comparing it with his previous testimony. Whatever the outcome of that might be, Williams said that based on his testimony, that officer had claimed neglect on his part and so he will be looking into holding that officer accountable as well. In relation to Nah and Caliz, the Commissioner confirmed that they both remain on interdiction due to the criminal charges against them that are still before the courts.

He explained, "One of the issues we have been noticing is that we have been saying to our adjudicators over and over is that our disciplinary tribunal is not a court of law per se. It is a process by which we allow proof of natural justice to take its course. It is a fact-finding tribunal, and the strict rule of evidence is not applicable. Likewise, it is not like in a court of law where persons must be found guilty based on the principle of beyond a reasonable doubt. In our tribunal, we have our civil standard which is on a balance of probability. But oftentimes we are seeing our adjudicators applying our criminal standards as opposed to the civil standards and they are acquitting officers on that basis." Nah and Caliz was among several officers who stand accused of playing a part in the November 2021 drug plane landing near Bladen Village in the Toledo District. Both officers were reportedly detained in a vehicle that had several rounds of ammunition inside at the time.

Senate Approve Auditor General's Two-Year Contract

Effective September 1st, 2022, Dorothy Bradley, will be installed as acting auditor general on a two-year contract after nine out of 13 senators voted in favor of her appointment despite being accused of victimization and questionable management stiles by employees under her command.

Bradley's appointment came following an extensive debate that took place in this week's sitting of the Senate which saw several senators divided on the topic. At the conclusion of the debate, Labour Representative Senator Elena Smith requested a division of votes on Bradley's appointment which resulted in nine votes in favor, resulting in the motion being passed in the Senate.

During the debate Smith disclosed that her office has also received calls as it relates to Bradley's

reappointment. According to her, several individuals had expressed their concerns about Bradley's professionalism, how she treats and interacts with employees, as well as several other issues that have emerged during her tenure as auditor general. "The NTUCB feels that if it is that we are putting this same person to head a department that has not been properly functioning, then it means that the department will continue to not properly function." Ν G 0 Representative Senator Janelle Chanona pointed out what she calls a disconnect between current employees at the audit department and Bradley. Chanona continued by saying that she would have preferred that a review or


scrutiny be done at the audit department to establish whether the accusations were true and if possible that an apology be made to Bradley.

"I am totally uncomfortable with the chasm that's been created between two sides on this. We cannot move forward in that light, and it does not make sense for us to proceed with something and then just say, well, you know what? We saw the writing on the wall before and we ignored it," expressed Chanona.

In the case of UDP representative, Senator Beverly Williams, she said "Wheel and come again." She stated that it cannot be that all the employees are wrong and only Bradley is right. While she said that she understood the lack of succession planning and the fact that Bradley is not easily replaceable she said that she was concerned about the staff's welfare and their mental health.

While Senator Alvin Benguche, from the church, said he was also concerned about the lack of succession planning he was prepared to support the appointment. That call was also echoed by PUP Representative Senator Collett Montejo who highlighted the fact that Bradley was hailed as an anticorruption champion during her previous tenure as Auditor General.

Bradley retired from her post as Auditor General in December of last year. Since then the Briceño administration had claimed that no succession planning was in place and a replacement was hard to come by so they offered Bradley a two-year contract to take over back the post while a replacement could be found.



"\$76 million in a single payment during a health crisis is an insult," says Tracy Panton

Government of Belize once more on the \$76 million payout to Belize International Services Limited (BISL), following countrywide protests by nurses this week.

On Monday, nurses all over the country walked out of their hospitals, demanding that the Government of Belize properly compensate them for overtime hours. Nurses at the Karl Heusner Memorial Hospital additionally raised the issue of a lack of basic resources such as tape for wound dressing and pain killers to give to patients. Panton told The Reporter that the motion tabled in the House of Representatives last week to make the \$76 million in a single payment is an insult to Belizeans. She went on to say that making such a payment during a situation so dire that healthcare workers took it upon themselves to

protest, then the priorities of the Briceño administration has been called into question.

"If our public hospitals don't even have Tylenol, I think that our government's priorities are in the wrong place," Panton said.

"This is a company, according to the Prime Minister, that grossed US\$86 million in 7 years. That had \$9 million worth of expenses," Panton said. "This is not a company that is broke; that is in dire need of this payment in a singular settlement." She said that, despite the Prime Minister's assurance that a team of "experts" negotiated the settlement at a discounted rate for Belize, the terms of payment were not in the country's favor and should have been negotiated in such a way as to make it less burdensome. Panton also raised major concerns about the way the settle-

ment was reached, pointing out that the CCJ had ordered that the Supreme Court of Belize conduct the valuation for the settlement to be reached with BISL; however the Briceño administration chose to go against that instruction and bring in the team of experts.

"For the administration that promised to implement the gold standard of transparency and accountability and good governance, I think the minimum has to be that they make this settlement arrangement available to the Belizean people who are now tasked with paying the bill," Panton said. Notably, the Ministry of Health and Wellness held an emergency meeting with the Nurses Association of Belize and made commitments to address the issues raised. Following negotiations, the nurses decided to discontinue further action.

Senate Presentation by Senator Kevin Herrera on BISL Settlement August 29th, 2022

There are bad agreements, there are horrible agreements then there are the BISL Agreements.

Background

On June 11, 1993 the Government of Belize and BISL signed a 10 year agreement for the management and development of the Belize International Merchant Registry(IMMARBE) and the International **Business Companies** Registry of Belize. Note that the 1993 election was June 30th, 1993 and so given that it is mandatory that the elections are held within 3 months after the dissolution of Parliament, it had to be that this agreement was signed when Parliament was dissolved. Since Parliament was dissolved at the time, it would have been impossible for this agreement to have been ventilated in Parliament after the signature.

On March 5th, 2003 elections were held again and the PUP came back to power. On March 9th, 2003 a 10 year extension was signed for this agreement. That is 4 days after the election, Madam President.

On March 24th, 2005 the agreement was additionally extended by 7 more years. Note Madam President that it is likely that this agreement was signed because of the February and March protests that were happening at the time. This agreement was a secret. How do we know it was a secret agreement? Because on May 9th, 2013 when the 10 year extension had expired, BISL wrote to the Government informing them about the 7 year extension and sending thema copy of the agreement. In the words of Financial Secretary in a June 4th letter to BISL, he said, "We are appalled by this document which we had not seen before, as no copy could be found in our records."

Financial Deal

Madam President, let me briefly go over some of the numbers to show how lopsided and treacherous this deal was.

I have the government figures for the period 2013 to 2020. I used those as a basis to get an idea of how much this deal could have been worth to BISL.

The sharing of the Revenues was done in the following manner, 9% was for Expenses, 36% went to Government and 55% went to BISL. On the Revenue side, this contract grossed \$737M. Of that \$737M, \$66M would have gone to pay expenses, \$265M would have gone to Government and \$406M would have gone to BISL. It gets worst, Madam President, this would have all been tax free, this \$406M.

The Settlement

Now the settlement. We are asked to settle with BISL in the amount of BZ \$76M in order to avoid going through further legal proceedings. This is the ask in front of us today. Madam President, by settling this matter now it is true that we will avoid a potentially worst situation down the road. By settling this matter now, BISL would be getting BZ\$30M less than they would have if they had remained in the contractual management of the registries. That is true. So, given the bad situation we are in, I guess it is the best outcome.

Government after the settlement, will be left with \$96M BZE. These are for the 7 years Madam President. Madam President, what we are not being told, that had we not gotten into this 7 year extension,

the Belizean people would have gotten \$172M over the last 7 years, not the \$96M.

One last thing on the settlement, Madam President, the government complained about the high cost of the \$5M referendum. It is adamant that it will recuperate the \$15M it lost from excise taxes on fuel and for that reason it has not allowed the local prices of certain fuels to fall correspondingly to that of world market prices. It can't afford more robust social programs and it has to continuously borrow for budgetary support and yet in the blink of an eye, it can find \$76M to pay BISL.

Madam President, in this tragedy perhaps there is room to learn so these things never happen the way they did again. I would like to propose that we amend the constitution to include a provision in which Government officials will be held personally liable for losses suffered in transactions that don't comply to the applicable laws that require certain degrees of disclosure. It was too easy for Mr. Musa and Mr. Fonseca to walk away from this mess. We have to do better than

that. The Senate should really consider bringing some of these people to the Senate to answer some questions. Madam President,

look at our roads, our hospitals, our schools. Look at the poverty that exists. There is so much need in this country and yet our leaders contracted to give a billionaire \$406M that could have easily be done by the government.

Ask yourself how we and future generations will benefit from that. The poor will not be allowed to ride the vathe or the private plane. What they are asked to do is to pay for those and more out of their meagre earnings.

Nobody has been held to account for this travesty, except for the already burden-ridden taxpayer, and by the way they are the only ones who had nothing to do with this.

Nurses countrywide walk out of hospitals in protest

Mon. Aug. 29th, 2022— Nurses from hospitals all over the country walked out of their hospitals on Monday, protesting that they are not receiving overtime payments that are due to them.

Nurses from the Northern Regional (NRH), Southern Regional (SRH), and Western Regional Hospitals (WRH), along with those from the Corozal Community Hospital left their posts Monday morning and took to the streets in their respective communities, demanding that they be adequately compensated for their time.

The nurses have raised special issue with the "short hour" deductions begging subtracted from their overtime, and for which they were told by their various administrations are deductions made for the hours they were on lunch break. "How can you make

deductions for a lunch hour, when we do not have a lunch hour?" one nurse from the SRH asked.

The nurses emphasized that they were on the front lines when the COVID-19 pandemic hit, endangering their lives and putting in far more work than was originally asked of them, and as such should not be cheated out of their compensation.



Can walking lower blood pressure?

Can walking lower blood pressure? We've long known walking has many health and wellbeing benefits, including strengthening our bones and muscles and helping us to maintain a healthy weight and lose body fat. It turns out the walking perks don't stop there.

Regular physical activity is associated with lower

blood pressure and therefore reduced cardiovascular risk. Walking to control your blood pressure, whether in the great outdoors or on one of the best walking treadmills, is easily accessible to most and is no different.

Dr. Mahmoud Al Rifai, a member of the American College of Cardiology who has been involved in multiple studies of cardiovascular risk, tells us: "We frequently advise our patients to engage in moderate-to-vigorous physical activity, and that can include walking." And it's not hard to see why.

According to the Centers for Disease Control and Prevention (CDC), hypertension (the more formal term for high or raised blood pressure)

affects 47% of people in the US. Furthermore the CDC estimates that only one in four adults with hypertension have their condition under control. Clearly, finding a reliable and consistent way to keep your blood pressure within healthy limits is more important than ever.

Below, you'll find everything you need to know about walking and its potential role in lowering blood pressure, including how it helps and exactly how much walking you need to do to see positive results.

'tone of the blood vessels'. He explains: "Blood vessels are surrounded by what's called smooth muscle cells. And these are muscle cells that can contract and relax. And what determines how contracted or relaxed they are, is the amount of sympathetic tone."

If you increase the tone, you raise blood pressure. If you decrease it, you lower blood pressure. "Walking



is thought to decrease the tone of blood vessels," Dr Al Rifai adds.

HOW MUCH WALKING DO YOU NEED TO DO TO LOWER BLOOD PRESSURE?

According to the Physical Activity Guidelines for Americans, adults should do 150 minutes of moderateintensity or 75 minutes of vigorous cardiovascular exercise each week. This might seem like a high number but you can hit this target by exercising for 30 minutes, four-to-five days a week.

Weight lifting, swimming and running lower blood pressure, and walking

WHAT ELSE CAN YOU DO TO LOWER BLOOD PRESSURE?

Dr Al Rifai says that the first step to lowering blood pressure is through therapeutic lifestyle interventions. He says: "Being physically active is very important. You can do physical activities, like doing yard work or going up the stairs, and dedicated exercise like jogging, swimming, weightlifting." Just make sure

you have one of the best water bottles with you so that you can stay hydrated during your workout.

Dr. Al Rifai tells us you can also reduce blood pressure by reducing salt intake. A study published in the journal of Electrolytes and Blood Pressure found: "A reduction in dietary salt from the current [global average] intake of 9-12 g/day to the recommended level of less than 5-6 g/day will have major beneficial effects on cardiovascular health."

Finally, you can reduce blood pressure by losing weight. Dr Al Rifai says: "Weight loss in itself can lead to dramatic reduction in blood pressure." There is evidence to prove it: in one study published in Hypertension, researchers

found that a 1kg loss of body weight was associated with an approximate 1-mm Hg drop in blood pressure.



BLOOD PRESSURE?

Studies suggest that it can. One systematic review, published in the Database of Abstracts of Reviews of Effects, examined trials conducted on walking and its impact on hypertension. The authors concluded: "There was evidence for the beneficial effects of walking on lowering either systolic or diastolic blood pressure, or both."

Another review, published in the journal of Preventive Medicine, found evidence to suggest that individuals who take up a programme of 'regular brisk walking' improve several known risk factors for cardiovascular disease – including high blood pressure.

The CDC defines systolic blood pressure, the upper number in a blood pressure measurement, as 'the pressure in your arteries when your heart beats'. The lower number in a blood pressure measurement, the diastolic blood pressure, 'measures the pressure in your arteries when your heart rests between beats'.

A normal blood pressure level is less than 120/80 millimeters of mercury (mmHg).

HOW DOES WALKING HELP TO LOWER BLOOD PRESSURE?

According to Dr. Al Rifai, walking decreases the

can have the same effect. In a review of 73 trials published in the Cochrane Library researchers concluded: "Our findings suggest that moderateintensity walking, three to five times per week, of 20 to 40 minutes duration, and 150 minutes per week for approximately three months could have an effect on lowering blood pressure."


Another study published in Hypertension Research found good evidence that walking 10,000 steps a day lowered systolic blood pressure in middle-aged male subjects . Fun Facts! The 24 hour clock!

L clock is a way of telling the time in which the day runs from midnight to midnight and is divided into 24 hours, numbered from 0 to 24. It does not use a.m. or p.m. This system is also referred to (only in the US and the English speaking parts of Canada) as military time or (only in the United Kingdom and now very rarely) as continental time. In some parts of the world, it is called railway time. Also, the international standard notation of time (ISO 8601) is based on this format. A time in the 24hour clock is written in the form hours:minutes (for example, 01:23), or hours, minutes, seconds (01:23:45). Numbers under 10 usually have a zero in front (called a leading zero); e.g. 09:07. Under the 24-hour clock system, the day begins at midnight, 00:00, and the last minute of the day begins at 23:59 and ends at 24:00, which is identical to 00:00 of the following day.

The 24-hour



12:00 can only be mid-day. Midnight is called 24:00 and is used to mean the end of the day and 00:00 is used to mean the beginning of the day. For example, you would say "Tuesday at 24:00" and "Wednesday at 00:00" to mean exactly the same time.

However, the US military prefers not to say 24:00 - they do not like to have two names for the same thing, so they always say "23:59", which is one minute before midnight.

24-hour clock time

is used in computers, military, public safety, and transport. In many Asian, European and Latin American countries people use it to write the time. Many European people use it in speaking.

Many models of digital wristwatches and clocks are available that display the time of day using the 24-hour clock.

In railway timetables 24:00 means the end of the day. For example, a train due to arrive at a station during the last minute of a day arrives at 24:00; but trains which depart during the first minute of the day go at 00:00.

To write shop opening hours until midnight use, for example, "00:00-24:00", "07:00-24:00".

Advantages over the 12-hour clock system:

Fewer confusions between morning and evening; e.g. 7 o'clock in the evening is called 19:00.

People do not have to figure out if noon is 00h00.m. or 12h00.m.

It is easier to calculate duration.







Tribute to my uncle, Clifford Alexander Baptist (1934 - 2022)

Clifford Alexander Baptist aka Fish, Baca, or Pescado was born August 2nd,1934 to Mr. Hubert Baptist and his wife Mrs. Clavia Baptist in the village of Bermudian Landing in the Belize District. He was the only child of that union.

Clifford attended St. Isabella R.C. School in the village with his four siblings Cleveland, Raymond, and Norma Lord and Eva Baptist. Cleveland, Raymond, and Norma were the first three children of his mother from an earlier relationship. Eva Baptist was the first child of his father from a previous relationship.

From his teenage years Clifford was always well-dressed and with a special attraction for ladies. It was therefore no surprise that soon after he graduated from high school, Clifford captured the heart of Miss Edna Garbutt, a beautiful young lady from the village Blackman Eddie in the Cayo District. After a brief courtship the couple got married in Bermudian Landing. That union produced four children Joyce, Elsworth, Kirk, and Rigel Baptist. The family was had an adopted son, Ronnie "Bolo" Baptist. **Clifford Baptist** had five other children. Those children are Luke and Godfrey Baptist from Lemonal, Errol Baptist of Double Head Cabbage, and Harry and Jude Baptist in the USA. In traveling as a boy with my uncle from Bermudian Landing to Belize City, the truck picked up a beautiful lady. Clifford quickly struck a conversation with the passenger. He eventually said to the lady, "I would like to be the water boy or handyman at your house." At that point I said to myself "My

uncle. My uncle."

After finishing high school Clifford took interest in carpentry and later became known as a reliable builder in his community. As a member of the Baptist Church that was being developed by American missionary Pastor Parson, Clifford was given the contract to build the Baptist Church and later the Baptist Missionary house followed by the Baptist School in the village. Those three buildings were his landmark achievement as a building contractor.

When he was not engaged in construction work, Clifford worked as a farmer with his sibling to support his family.

Clifford got his first opportunity to travel to the United States in 1968 with the Baptist missionaries. He however remained in the United States only briefly and returned to Belize. On his return to the country Clifford used the knowledge he gained abroad to uplift himself and his family as a grocer, a hunter, building contractor, logger of mahogany, and later as a commercial farmer with rice, beans, pigs, and cattle. Clifford Baptist was an ambitious person. He was always dedicated to pursuing his dreams including providing his family with the best possible life despite many challenges and setbacks along the way.

After a good season as a logger he built his own house in the village and opened a grocery store. A few years later he suffered a huge financial lost, when many of his logs were lost at sea due to a huge unexpected flood .Clifford used the unfortunate incident as a learning experience to rebound with logging. Later he suffered another huge financial lost when an unexpected flood destroyed acres of his beans and rice. He



In their primary school days Clifford's children were upset when he whipped them with a belt to get them to focus on their schoolwork. Today however those children are thankful that their father did not allow them to neglect their education and become primary school or high school dropouts.

Clifford Baptist was a community activist. As the Chairman of Bermudian Landing, he organized a number of sporting events, dances, cleanup campaigns, and meetings with the villagers and Fred Hunter the then Area Representative to uplift the community.

One of the greatest horse races at the racetrack in Double Head Cabbage featured Tight Fit for Clifford Baptist vs. a horse for Mr. Pratt from St Paul's Bank.

In the buildup to the six furlong race Mr. Pratt said that his horse would defeat Tight Fit so badly that it would be called Sleck Fit afterwards.

The day of the race huge bets were on the line; the track was rather silent as the two horses galloped neck and neck for the first three furlongs; then the crowd burst with joy as Tight Fit for Clifford Baptist gradually increased its lead over its rival by half length, then a length to win the race by at least three lengths. For years many villagers remember the great fundraising and the extraordinary fun Belizeans from near and far had, when as Chairman of his village Clifford Baptist took the gamble and invited Bameki Bandula the hottest band in Belize in those days for a village dance. A lover of his country, Clifford had strong political views. He supported the Opposition National Independence Party (NIP) for many years, and later campaign for accountant and independent candidate Leslie Day, who was unsuccessful in his bid to unseat Fred Hunter, the veteran Area Representative for Belize Rural North.

Clifford was also a caring person. Like his parents for many years he offered lodging at his home to families from the village of Lemonal, who had to spend the night in Bermudian Landing to take the morning truck to Belize City, as their eight mile village road was totally trafficable by vehicles.

Clifford was gainfully employed in the United States until he met the retirement age. He continued living in the USA until the Lord took him home on August 13, 2022 at the age of 88.

Clifford Baptist was a loving father, husband, grandfather, great grandfather, uncle, nephew, friend, and community activist. He will be sadly missed

FIFA President Infantino visits Belize

∎ianni Infantino, J the president of the Federation of International **Football Associations** (FIFA) visited Belize for the first time this week on his goodwill tour of Central Americana and the Caribbean. Infantino joined President Sergio Chuc of the Football Federation of Belize in a media briefing at FFB Institute in Belmopan Wednesday o n afternoon, August 31. His visit coincided with a week-long football festival for primary school children at the FFB Stadium, as part of the launch of the FIFA "Football in Schools" project which FIFA is funding for Belize with \$100,000. The children welcomed Infantino and his delegation, waving Belize flags.

Belize was the 14th country, among the 211 member countries of FIFA

to participate in the project. Over 10,000 school children at 100 primary schools around the country will learn the game of football this academic year through the program. It's a

4-year program of football development which will expand gradually, for football to become a part of the physical education curriculum at all schools. It is the fulfillment

of a partnership agreement which the Ministries of **Education and Sports** signed with the FFB in June 2021. Infantino expressed

his satisfaction at what the FFB has

he global L community is confronting a number of unprecedented crises: from the ongoing challenge of COVID-19 variants and stalled efforts on climate change, to supply chain disruptions and Russia's unprovoked invasion of Ukraine. Now more than ever, China's increasing rhetorical and military intimidation is jeopardizing regional peace and stability. All these will impact security and well-being of the world. As the UN members meet again in New York this year, it is worth reminding these leaders that all people—including the people of Taiwan—deserve to have their voices heard and to be part of the collaborative effort to tackle these challenges for the global good.

A beacon of democracy in Asia and a force for good in the world, Taiwan is a valuable partner that can help overcome these global challenges. Since the outbreak of the COVID-19 pandemic, Taiwan has provided humanitarian support across the globe, including muchneeded masks and medical supplies, as well as developing and sharing its homegrown vaccine. Taiwan also sent over 550 tons of relief supplies to the people of Ukraine following the Russian invasion of their country, in addition to making over US\$40 million in donations for Ukrainian refugees. Further, Taiwan is committed to combating climate change, with a blueprint for net-zero carbon emissions by 2050 and policies in place to help achieve the UN Sustainable Development Goals. As the world's 22ndlargest economy in

terms of GDP and a major semiconductor manufacturer, Taiwan plays a key role in global supply chains. And as a defender of democracy, Taiwan is working to safeguard the status quo and support the rulesbased international order. While China is using coercion to export its brand of authoritarianism abroad, Taiwan lets its free and open society lead by example.

Sadly, Taiwan is unable to participate in the largest and most important forum of global cooperation due to the relentless suppression by the People's Republic of China (PRC). By deliberately conflating its "One China" principle with the UNGA Resolution 2758 the resolution that determined who represents "China" in the organization some 50 years ago— Beijing is misleading the world by spreading the fallacy that Taiwan is a part of the PRC. Contrary to these false claims, the resolution does not take a position on Taiwan, nor does it include the word "Taiwan." The longterm status quo is, the ROC (Taiwan) and the PRC are separate jurisdictions, with neither subordinate to the other. The people of Taiwan can only be represented in the international community by their free and democratically elected government. The wrongful interpretation of UNGA Resolution 2758 has long deprived Taiwan of the right to participate in the United Nations and its specialized agencies, and it has also denied the international community of an opportunity to benefit from Taiwan's contributions. Worse yet, the PRC's efforts to rewrite Taiwan's status at the UN further undermine

global peace and stability. Beijing's recent dangerous military maneuvers surrounding Taiwan is a case in point.

The UN Charter states clearly that the purposes and principles of the United Nations are to maintain international peace and stability, and that international disputes should be resolved by peaceful means. However, Beijing continues to conduct military exercises in areas around Taiwan, undermining the status quo in the Taiwan Strait, escalating tensions, impacting international trade and transportation, putting a n d regional peace and security at risk. Such irresponsible actions need to be condemned and brought to a halt. Given the current circumstances, it is even more important that UN and its member states stop allowing such a member, which ironically is a member of the UN Security Council, to dictate the positions of the organization to suit its own political agenda. Acquiescing to China's wrongful claims over Taiwan will only destabilize the region, which is also against the very purpose of the UN.

Taiwan will resolutely defend its sovereignty and security. As a responsible member of the international community, Taiwan will also continue to exercise restraint in response to China's provocations, and work together with like-minded countries to uphold peace and stability in the region. And as we have shown the world over the years, we will continue to fulfill our international responsibilities by actively engaging with and contributing to the international community. The theme of

the 77th session of the UN General Assembly, "A watershed moment: transformative solutions to interlocking challenges" pointedly reminds us of the grave challenges facing the international community: the COVID-19 pandemic, food and energy shortages, disrupted global supply chains, and climate change, the list goes on. When the UN talks about "joint solutions" and "solidarity" to tackle

"interconnected crises," we could not agree more. Taiwan is more than willing and able to be part of such joint solutions. And the 23.5 million resilient Taiwanese people surely should not be excluded from such important global efforts.

We are thankful that countries worldwide are beginning to realize what Taiwan can offer and many support Taiwan's robust participation in the UN system. Among them, the European Parliament overwhelmingly approved resolution on July 6 this year expressing support for Taiwan's meaningful participation in international organizations. The G7 countries have also expressed similar support. In particular, US Secretary of State Antony Blinken publicly encouraged all UN member states to join the United States in support of Taiwan's meaningful participation in the UN system last October.

 Legal Tender Status of £20 and £50 Paper Banknotes

Belize City, 16 August 2022: The Central Bank of Belize hereby informs the public that the Bank of England has notified that it will withdraw the legal tender status of £20 and £50 paper banknotes on 30 September 2022. After this date, only polymer banknotes will be legal tender. The Bank of England is encouraging both individual and institutional noteholders such as financial institutions to use, deposit, or exchange these banknotes by 30 September 2022.

Members of the Belizean public holding these paper banknotes are advised to submit them for exchange at their domestic bank. Institutional noteholders in Belize should continue to return these sterling banknotes to the Central Bank for repatriation to the Bank of England.

Note that after the 30 September 2022 deadline, holders of paper sterling banknotes will no longer be able to use them in transactions.

'' A s t h e Commissioner of Police, I saw it fit that it would not have been prudent to hold a protest in the area of a gas station." This is how the Commissioner of Police Chester Williams explained the Belize Police Department's decision to deny the United Democratic Party (UDP)'s request to stage a protest last week Thursday in Belize City.

Last week, the Vice President of the Human Rights Commission of Belize (HRC) Cynthia Pitts had frowned upon the Police Department's refusal to grant the UDP permission to hold their protest and cited that it was a violation of their right to freedom of peaceful assembly and association.

wenty-year-old Derrick Uh of Christo Rey Village, Corozal is the latest in a long line of youths who have perished at the hand of our police officers since our Independence on September 21st, 1981. He will not be the last. I know of no youth who lost his life while in police custody prior to 1981. The Belize Police Force in the era of British Colonial rule in Belize was competent, professional and exemplary. It benefitted tremendously from the mere fact that it was part and parcel of the Police Force of the Mighty British Empire.

In contrast, today's Police Force is severely emaciated, seriously disunited, intellectually and morally wanting, lacking in adequate leadership and training, frightfully undisciplined and piteously devoid of resources - material and financial. Unless urgent steps are taken to reform it comprehensively, it runs the very real risk of evolving into our nation's most dangerous institution.

Incidents such as the negligent death of Derrick Uh in a metal cage while restrained in a windowless goods van on a torrid August day, the unprovoked execution by gunshot in the back of Laddie Gillett on an empty beach in Placencia and the fact that our country ranks 7th in the world for homicides, are irrefutable evidence that our Police Force has lost the ability to protect and preserve the citizenry of our nation. None of this is the fault of the ordinary policeman. It is the inevitable consequence of a deliberate policy pursued by all our Post Independence governments. I have long agonized over the inexorable, precipitous and dangerously declining fortunes of our Police Force. I witnessed the onset of its decline in the early 1980's. I was then practicing law in partnership with the late B.Q. Pitts, one of Belize's early titanic criminal defence attorneys.

Because government was both the single largest employer of our labour force and the single biggest spender in the country. The limitations imposed by the IMF negatively impacted our economy and made life even more difficult for the poor.

The right to marriage in international law: A response to the Human Rights Commission of Belize

On August 14, the Human Rights Commission of Belize submitted an article to The Reporter, which in turn was lifted from a United Nations press release. Despite the ostensible credibility of a UN statement, the contents of the article constitute egregious and highly deceptive misinformation about the status of international human rights law on the issue of marriage, and its ramifications.

There is no human right to same sex marriage. International human rights law, as based on the foundational tenets of the Universal Declaration of Human Rights, clearly states that men and women "have the right to marry and to found a family". Adopted by the UN General Assembly in 1948, and consistently reaffirmed in subsequent treaties, the plain meaning of this provision relates clearly to marriage between man and woman.

Now, we live in times in which the meaning of marriage has been obfuscated, and we cannot shirk from answering with great clarity the fundamental questions of human existence. What is marriage? Is it any close relationship? Or something entirely unique?

Marriage is the union between a man and a woman, unparalleled by any other social contract. As in 1948, the majority of countries around the world continue to espouse this view. Even as political tides come and go, for the great majority, marriage is something immutable, firmly rooted in cultural and religious truth across the world.

As debate on the true meaning of marriages rages, what we must agree on is that marriage is a matter of public marriage brings adverse effects across all of society.

The hope is that marriage will thrive in Belize, and that the proper foundations for a flourishing family life will be created and supported by both government and

The decision to create a marital union ripples out to family, friends, and often, to children, all of whom become interdependent, in many ways, for support and subsistence. The more marriages fail in sustaining the life of others around them, the more the state is called to intervene. The devaluing of

civil society. It must be stated without reserve that it is the right of the people of Belize to determine for themselves how marriage is defined in their country. This is a crucial determination to be made at home in accordance with Belize's democratic processes, not imposed from above by a faraway bureaucratic institution.

While international law is firmly grounded in a conception of marriage between man and woman, elements of the UN bureaucracy have, most unfortunately, embraced radical reinterpretations of the law in a bid to compel countries to embrace a reimagined world order. The UN has a specific office dedicated to just this-an "independent expert" on "sexual orientation and gender identity" that points the finger at countries that aren't doing enough to advance this agenda. Far from stopping at same-sex marriage, this office calls for unfettered rights for "gender diverse" children in clear violation of the rights of parents and with total disregard for fundamental human rights to conscience and religious freedom. It's no wonder that it is heavily contested by UN Member States at every opportunity. The UN is far from alone in its mission to eradicate the foundational norms that have served as the

society since time

immemorial. Powerful


governments (the United States of America being chief among them) increasingly have ramped up the pressure to force developing countries into accepting the complete redesign of the marriage institution. But most of the world still resists—only 32 out of 193 UN Member States have changed the legal definition of marriage. Even where it has been changed, judicial activism has often led the way, creating a dramatic societal shift without respect for democratic processes and support from the people.

Faux interpretations of human rights law are invoked to clobber judges, lawmakers, governments, and citizens into submission. No doubt, the understanding of the distribution of rights and duties of spouses within marriage has changed since the international human rights project was first launched in 1948. But the law's acknowledgement of the essential structure and common duties of the marriage relationship has not-and remains unchanged in accordance with the same understanding of marriage that has guided us throughout human history. It must be noted that laws that prohibited interracial marriage were rightly condemned precisely because they violated the right to marriage enshrined so clearly in international law. Readers without detailed knowledge of the international system will be excused from accepting the falsehoods promoted by some UN bureaucrats and parroted by Belize's HRC. Much like in the tale of the Wizard of Oz, behind the proverbial curtain of the bureaucracy's various "special mechanisms," "high commissioners,' and "independent experts," there is nothing more than an individual, with his

or her own biases and policy goals about how human rights should be interpreted, which they get to push on the rest of the world with the clout and cover of being an officer of the United Nations. Such views are not scientific or empirical conclusions, but rather subjective views that, like any opinion, are inseparable from the author's bias.

That said, these offices wield tremendous authority, and all too often, countries, in particular those of the developing world, have little choice but to follow their directivesknowing full well that they are not binding, but lacking the ammunition to withstand the pressure that the international institutions levy via foreign aid and other avenues.

The Interamerican Court of Human Rights (under which Belize is under no jurisdictional obligation) has been particularly subject to ideological advocacy from its judges, issuing an advisory opinion in 2017 in which a majority of its members asserted an alleged duty of states to reform their marriage law to accommodate same sex couples. This is not only nonbinding, but also directly contradicts the American Convention of Human Rights, which the Court was created to uphold. And State can and should contest and oppose such a reading. Many have done so already, with the Peruvian Constitutional Court being the latest to join its voice in dissent and in condemnation of the body for twisting the meaning of the Convention. Belize must stand on guard, resisting fraudulent calls to change time-honored laws and values in an effort to keep up with radical ideologies. Strong marriages build strong societies, and now is the time to recommit to the institution of marriage, for today and future generations in Belize.

First of all, take a look at Article 23 of the Universal Declaration of Human Rights -"Everyone has the right to work, to free choice of employment, to just and favourable conditions of work and to protection against unemployment. Everyone, without any discrimination, has the right to equal pay for equal work. Everyone who works has the right to just and favourable remuneration ensuring for himself and his family an existence worthy of human dignity, and supplemented, if necessary, by other means of social protection. Everyone has the right to form and to join trade unions for the protection of his interests."

They also exercised their right as stated in Article 20 which, "combined with Article 19's freedom of expression, together ensure the right to gather publicly or privately and collectively express, promote, pursue and defend common interests". Healthcare workers hold critical roles in the provision of care and the optimization of health services in all of Belize and it is important for the public to understand that they can only provide optimum services if they are provided adequate working environments and resources. Unfortunately, and many families can attest to this after visiting a public health facility, they don't have these. In 2021, Human Resources for Health explored how employment and working

conditions negatively affected the health of nurses in countries including Brazil, Croatia, India, Ireland, Italy, of depression and 38.9% of insomnia. Moreover, this systematic review also found gender and occupational differences, where female nurses had higher rates of affective

This, however, cannot be achieved if health systems lack proper supplies, equipment, medical staff or even medical facilities to serve the community. The Belize Medical and Dental Association stands in solidarity with nurses and reiterated in a release that "There is a lack of medications and resources to be able to properly care for patients, as well as under-staffing that may compromise quality and timely care." 



CONSUMER PRICES UP 7.3% IN JULY 2022: MOTOR VEHICLE FUELS, FOOD, AND LPG PRICES MOST AFFECTED

Overall National Inflation Rate¹ (All-Items):

For the month of July 2022, the All-Items Consumer Price-Index (CPI), which summarizes price levels for all categories of consumer goods and services, stood at 111.5, up from a CPI of 103.9 recorded for July 2021 (see Figure 1). This indicates that the country experienced an overall national inflation rate of 7.3 percent on the cost of goods and services regularly purchased by Belizean households. This considerable overall increase in consumer prices was driven by rising prices across almost all CPI categories, most notably Mineral Fuels and Lubricants' and 'Food and Non-Alcoholic Beverages'. Significantly higher prices were seen for items such as motor vehicle fuels, various food products, liquefied petroleum gas (LPG), restaurant services, cinema entrance fees, and house cleaning and maintenance products.



Transport:

As has been the case in recent months, Transport' accounted for almost a half of the increase in consumer prices for the month of July. The category recorded an inflation rate of 22.5 percent, driven mainly by fuel prices, which were up by 33.2 percent on average compared to last July. This was, for the most part, a reflection of rapidly rising prices for premium gasoline, which were more than 50 percent higher than in July of last year (see Figure 2). At the pump, premium gasoline registered an increase of \$5.95, with the average price per galon up from \$11.74 in July of last year to \$17.69 in July of this year. Diesel was up by \$2.81 from \$10.72 to \$13.53, while regular gasoline rose by \$2.50 from \$11.11 in July of 2021 to \$13.80 in July of 2022 (see Table 1). Additionally, passenger transport services rose by 13.8 percent, as increases in bus fares,

Recreation, Sport, and Culture:

Prices for 'Recreation, Sport and Culture' were 6.4 percent higher than they were in July of 2021, reflecting mainly higher cinema entrance fees (see Figure 2).



Furnishings, Household Equipment, and Routine Household Maintenance:

The 'Furnishings, Household Equipment, and Routine Household Maintenance' category recorded an inflation rate of 3.3 percent for July 2022. This was mainly the result of a 9 percent increase in prices for laundry products, soaps, and detergents (see Figure 2).

Information and Communication:

Due to lower prices for internet provision services, 'Information and Communication' continued to be the only major category recording a decrease, with prices within this category were down by 0.8 percent for the month (see Figure 2).

Inflation Rates by Municipality:

With an inflation rate of 9.8 percent, well above the national average, Orange Walk Town recorded the highest rate of increase in consumer prices for July 2022. Consumers in this municipality saw above-average increases in prices for various food items, home rental costs, restaurant services, laundry products, scaps, detergents, and women's clothing. On the other hand, the City of Belmopan recorded the lowest inflation rate at 5.9 percent, as consumers in this city saw lower than average increases in prices for food items, restaurant services, and laundry products, scaps, and detergents (see Figure 3).





1.4 percent and 2.8 percent, respectively (see Table 2). Within Food and Non-Alcoholic Beverages', fresh vegetables, dairy products, and cereal products saw the most significant increases, while an 11.5 percent rise in premium gasoline prices between June and July of this year accounted for the inflation within the Transport category over the one-month period.

Year-to-Date Inflation Rate3:

The year-to-date inflation rate for the first seven months of 2022. when compared to the same period in 2021, stood at 5.8 percent. The 'Transport' category, with a year-to-date inflation rate of 18.4 percent, was directly responsible for more than a half of the overall increase in consumer prices for the seven-month period, as considerably higher costs were recorded for all motor vehicle fuels. new motor vehicles, and various passenger transport services. The Food and Non-Alcoholic Beverages' category was up by 6 percent, due mostly to higher prices for cereal products, meats, cooking oils, seafood, dairy products, and fresh fruits and vegetables. Prices within the category of 'Housing, Water, Electricity, Gas and Other Fuels' were up by 2.9 percent, due to higher prices for LPG and construction materials for household use. Among the other categories, prices were also notably higher for restaurant services, laundry products, scaps, and delergents. Nonetheless, these increases were partially offset by a 0.8 percent reduction in the Information and Communication' category, as a result of lower prices for internet provision services (see Table 3).





taxi fares, and sea fares were seen across the country, while prices for new motor vehicles were up by 6.1 percent compared to July of last year.

Food and Non-Alcoholic Beverages:

Food and Non-Alcoholic Beverages' had an inflation rate of 8 percent, the highest recorded so far for this category in 2022, as all food sub-categories saw rising prices during the month (see Figure 2). The most striking increases were recorded for meats, cooking oils, dairy products, and cereal products. Specific items that saw the most notable price changes for the month included, pigtails, vegetable oils, coconut milk, various chicken parts, rice, eggs, natural milks, trish potatoes, watermelons, and cabbages. Nonetheless, lower prices were recorded for a few food items, including some fresh produce such as tomatoes, oranges, onions, black beans, and red kidney beans (see Table 1).

Housing, Water, Electricity, Gas and Other Fuels:

In comparison to July 2021, prices for Housing, Water, Electricity, Gas and Other Fuels' saw an overall increase of 3.3 percent for the month. Within this category, LPG prices were up by a significant 22.9 percent, as the average cost of a hundred-pound cylinder of this product rose by \$26.73, from \$116.52 in July 2021 to \$143.26 in July 2022 (see Table 1). In addition, prices for construction materials for household use were up by 14.3 percent, while home rental costs were up by 0.6 percent compared to the same month last year.

Restaurants and Accommodation Services:

The category of 'Restaurants and Accommodation Services' recorded an overall inflation rate of 5 percent for the month of July 2022 (see Figure 2), driven mainly by higher prices for restaurant and cafe services.



Month-Over-Month Inflation Rates2:

While inflation rates are generally calculated as the percent change in prices for specific items between the current time period and the same period of the previous year, another useful measure for tracking short-term changes in consumer prices is the month-overmonth inflation rate, which measures the percent change in prices between the previous month and the current month.

Over the one-month period between June 2022 and July 2022, consumer prices increased by 0.9 percent on average. The categories of 'Food and Non-Alcoholic Beverages' and 'Transport' were solely responsible for this increase, recording inflation rates of

The month-over-month inflation cate measures the percentage change in prices between the previous month and the current month. It is useful for capturing shirt-term price changes but is also affected by seasonal price movements.
