## Global Recession in 2023?

### IMF Director: There is a 25% risk of global downturn next year

"We think that the risk of global recession is now 25 percent," International Monetary Fund (IMF) Managing Director Kristalina Georgieva said to the media Thursday.

Responding to journalists' questions following her statements made at Thursday's press conference to highlight the Fund's Global Policy Agenda (GPA), Georgieva explained, "The probability of a recession has gone up. We [The IMF] estimate that one third

## Police officer shot to the head, critical

Afemale police constable was admitted to the Karl Heusner Memorial Hospital (KHMH) in critical condition this week after she was shot twice to the head in Dangriga.

On Wednesday, October 12, around 7:00 p.m., 27-year-old PC Lorray Arzu was with 45-year-old Lionel Rowland, on St. Martin Street, when Rowland reportedly had an exchange of words with another man.

Subsequently, both Arzu and Rowland entered Rowland's vehicle when the other man pulled out a .9mm pistol and opened fire, hitting Arzu in the head and hitting Rowland three times in the face and once to the back.

They were both treated at the Southern Regional Hospital (SRH) but Arzu was



later transferred to the KHMH where she underwent brain surgery. She remains in the Intensive Care Unit on life support.

Commissioner of Police Chester Williams stressed that Arzu, who joined the department in December 2021, was collateral damage in the incident as Rowland was the intended target.

"It just so happened that some of the bullets passed him and hit Ms. Arzu," Williams said.

Williams said that the police department is seeking the best medical advice and treatment options for her, while a joint team of the Special Patrol Unit (SPU) and Mobile Interdiction Team (MIT) to find the shooter.

ropical Storm Julia was not expected to amount to much!

It started up closer to the equator that most other storms and it pushed resolutely to the west, which is unusual for tropical storms, which at some point tend to tilt toward the north west.

It closed in on Nicaragua last Sunday, barely a hurricane, with winds of 75 miles an hour.

But this storm was a demon. It avoided the mountains of Nicaragua and raced across Costa Rica to the Pacific.

The rain which Belize received, up to 10 inches in some places, came as a surprise to most. This was a fast-moving storm - small but impactful.

It did considerable damage to middle Belize, causing flash flooding from the coastlands of Stann Creek to most of the Cayo District and affecting some of our best farming lands including pastures. The rains caused three key Belizean rivers - the Sibun, the Macal and the Mopan to overflow.

Water from the Mollejon Dam had to be released to relieve pressure on the dam wall, and all this water came thundering down into the central plains.

Belize City was spared because of the many lakes and lagoons which traditionally absorb and store excess water from the mountains, and so low-lying Belize City escaped much of the deluge. Belmopan too was spared, because of its strategic location and good drainage.

San Ignacio and Santa Elena absorbed the brunt of the deluge and many households were affected. There appears to have been no loss of life, from the storm, although there were a few close calls.

With only six weeks of the hurricane season left to play out, Belizeans are keeping their fingers crossed.

Hurricane Julia could have been catastrophic for us if it had moved just one half degree higher (35 miles) in latitude.

So we give thanks to God that our country was spared from a heavier blow.

### **Poultry Association:** Avian Influenza never confirmed in Belize

While Cabinet has given the all-clear for Avian Influenza, in Belize, the Belize Poultry Association has told The Reporter that the virus was never formally detected in the

Late on Thursday evening, Armando Cowo, the manager of the Belize Poultry Association, said, "I am not too sure how to say this but the Avian Flu suspected case was never confirmed, and though we had that suspected case, we took proactive measures to contain the virus in the event that it was there."

Cowo added, "With the assistance of BAHA and the Ministry of Agriculture, we conducted the necessary depopulation at the time and quarantined the area, and all other measures necessary to keep the possible virus contained."

He explained that samples were sent to the National Veterinary Services Laboratory, which is the World Animal Health Organization reference lab for the confirmation of diseases. We sent a lot of samples to them, and they have all come back negative," Cowo shared. "Therefore, the disease is not present in the county as we speak."

Cowo explained that while they were aware that the birds were having difficulties with some type of disease, they were not able to pinpoint exactly what it was. Cowo also noted that they were also distracted by the possible A-I + test and the need for them to implement the containment measures as soon as possible. Since the birds have been depopulated and the barns sanitized, Cowo said that they will now have to wait until whatever it was rears its head again so that they can retest.

"We have not finished tallying the numbers yet because we were waiting for the all-clear from the government because all measures were in place until the government gave the all clear. Now that they have given that we can go in and do the tallying of numbers of all the costs and the losses. So hopefully by next week, we should have that for you," explained Cowo.

In total, Cowo said that over 30 thousand birds, some only three weeks old, were killed

during the depopulation exercise. One of the barns had 24 thousand birds while the other had over four thousand and a smaller farm had about 1,500. The Association is expected to meet on Tuesday at which point it will decide whether losses will be determined by the cost of loss or cost of income. Once that determination is made then a field assessment will be conducted.

Also on Thursday evening, a Cabinet release stated, "The Minister of Agriculture notified Cabinet that the quick response by government and poultry producers to address the outbreak of the Avian Flu in Belize was successful. All tests conducted by Belize Agricultural Health Authority show Belize is completely free of the avian influenza virus. As such, quarantine measures have been discontinued."

In mid-September of this year, the Belize Agriculture Health Authority reported what appeared to be a suspected case of Avian Influenza on a farm in Blue Creek Village. While samples were sent abroad for confirmation, depopulation exercises and quarantine measures were carried out at three farms, almost immediately in an effort to stop the spread of the suspected virus.


of the world economy e quivalent will experience two or more consecutive quarters of negative growth."

It must be noted that the response during the question-andanswer session was less measured than the words of Georgieva's prepared statement, in which she suggested that the "outlook shows ...[a] 25 percent chance that global growth could drop to a historic low of 2 percent next year." According to the Fund's World Economic Outlook (WEO) database, the global economy—save only for recession years 2009 and 2020—has not seen global growth below 2.5% since 2001.

The projected pace of growth is slowed in large part by recordbreaking inflation levels not seen in the world economy for several decades. "The cost-of-living crisis, tightening financial conditions in most regions, Russia's invasion of Ukraine, and the lingering COVID-19 pandemic all weigh heavily on the outlook," summarized the Fund in its WEO report for October 2022.

Among the policy priorities highlighted, Georgieva advised policymakers to prioritize "protecting the vulnerable, the vulnerable households. the vulnerable businesses that are so important for the economy to function." Acknowledging the fact that governments have limited fiscal buffers, the Fund's managing director reminded that policy measures should be temporary and targeted towards the most vulnerable.

"Steer away from across-the-board



fiscal support that is neither effective nor affordable," cautioned Georgieva. "If we are to help people and fight inflation, we must ensure that the fiscal and monetary policy go

hand in hand."

Global average inflation is forecast to rise by 8.75% for 2022 and by 6.5% in 2023. The last time the world economy experienced inflation beyond six

percent was in 2008, when it was recorded at 6.3 percent.

Closer to home, the forecast for Belize's average (year-on-year) inflation rate for 2022 has been revised up to

6.6 percent, and at 4.7 percent in 2023. Within the last two decades, the last time Belize's inflation was above 6 percent was likewise in 2008, when it had reached 6.39 percent.

### Cabinet approves sargassum removal project

The mission to rid Belizean shores of sargassum pollution is set to begin as the Cabinet has approved the signing of the memorandum of understanding between Belize and Variodin.

The relationship between the German technology company and Belize began back in September when the Prime minister and a delegation were invited to Germany by Variodin. The Prime minister attended with hopes to find technological solutions to Belize's sargassum plight.

Varidin specializes in processing

materials of all kinds into electrical, thermal, cooling, and hydrogen energy. Their main objective is to produce green energy, and biodiesel and to supply green heating and cooling from waste. With the approval of their operations, Belize gains hope for a sustainable source of energy as well as an increase in tourism as the beaches are restored to their former state.

waste and residual

For decades, Belize has been in need of a viable solution to counteract sargassum pollution. Not only does sargassum deter visitors from the beaches across the nation, but it also poses various health concerns for those forced to inhabit the area surrounding them. Studies show that long exposure to it can cause heart palpitations, shortness of breath, dizziness, vertigo, headaches, and skin rashes.

Variodin now adds Belize to its list of partners as it has completed projects with countries such as South Africa, China, Denmark, Norway, and Afghanistan. The details of such an endeavor are yet to be released. However, the MOU will set the conditions for capitalizing on and mitigating the growing threat of sargassum to the region's critical tourism industry by using it to produce energy.

## Code Caribbean Project sparks outrage over invasive questions

Parents of students in Belize have joined parents in Barbados in their outcry and opposition to the Code Caribbean Project survey, which despite being deemed invasive to underage students, was distributed in schools without parental consent.

The backlash started over the weekend resulting in the Ministry of Education, Culture, Science, and Technology issuing a press release. The ministry confirmed that the survey, consisting of the Child Behaviour Checklist Youth Self Report is a part of the Code Caribbean Project. The survey, according to the Ministry, which was administered in both Belize and Barbados on September 26th, is a general assessment instrument used in a variety of settings, including by pediatricians and

The Ministry confirmed that five participating schools in Belize were asked all the questions on the survey while students in the remaining participating schools did not answer the questions in the CBCL sections. The Ministry concurred that "while these questions are deemed

to be a measure of mental health and well-being, this ministry shares the concern of the public regarding the nature of the questions, which have been removed. The ministry hereby assures the public that the practice of seeking parental consent will continue to be observed."

The Code Caribbean Project is a two-year computer science program designed to build both socio-emotional and entrepreneurial skills in students. It will introduce students to coding and develop math, comprehension, and writing skills. The main objective is to expand technological skills that will spark innovation and diversification for young people by the time they have completed secondary school.

The project which was being implemented in Belize and Barbados through funding from the Inter-American Development Bank asked students questions about their sexual identity, sexual urges, drug use, suicidal thoughts, and self-

harm among others.

We attempted to contact the CEO of the Ministry of Education Dian Maheia for further information on the survey and whether the Ministry was aware of the questions, among several other concerns but she responded that she was out of the country and that the ministry had already issued a press release on the topic.

In Barbados, the Ministry of Education had accepted responsibility for what it claimed was the "unfortunate exposure" to some of its secondary school students. The ministry alluded to the fact that the Inter-American Development Bank had failed to honor a prior commitment by the ministry to remove the offending questions before administering the survey to students.

The ministry, however, took responsibility and apologized for failing to vet the final survey before it was administered to the students. The ministry also assured parents that the offensive scripts would be destroyed and that no further use of the survey would be conducted without their full scrutiny.

### **MOHW: Plans in the pipeline to address** mental patients loitering Belize City streets

For several years, there have been questions and concerns from the public about the loitering of mentally ill patients on the main streets of Belize City and the potential impacts that it could have on

being a major tourist attraction as well as safety concerns for residents and students who traverse these areas.

It has been a longstanding issue that The Reporter has been monitoring for some time, and last week Quintanilla, mental health coordinator for the Ministry of Health and Wellness, said, "Definitely there has been a directive in terms of addressing the current situation with the homeless in Belize City. ... It is something that is being looked at

While Quintanilla refrained from going into any other details, she assured us that the situation would be addressed soon. She also told our newsroom that while it might seem that there aren't any systems in place for the homeless and mentally

seen around Belize City, she indicated that they could access assistance from the Port Loyola Health Clinic. Those include access to hot meals, clean clothes, baths, and any other hygienic, health needs that they might require.

"Unfortunately, I think because of the distance in going over there these patients are not accessing it that much, because it is just easier to be downtown and beg for food and get it, so I guess that is what happens."

Quintanilla, however, stressed that while it might seem like the issue is only limited to Belize, she pointed out that other countries such as the US and even the UK are grappling with the issue as well. The problem with that she said is that once they are not causing any harm to themselves, or to the public then they cannot be forcefully

"They are entitled to being out there free iust like anybody else. Those are their human rights and that is why it happens in the bigger countries like the UK and the USA. So yes, while I understand that it is not the best sight for tourists for the public itself whom they tend to bother, in terms of asking for money or for food and being out there dirty, it is not something that we can fix overnight," Quintanilla indicated.

Recently, concerns from the public had arisen after a suspected mental patient had attacked a female student in Belize City and sliced her cheek with a knife. That prompted concerns from the public about the safety of other students who traverse the Queen Street area where many persons with mental health patients and homeless persons loiter.

## following extortion claims

Yommuters and drivers traversing the George Price Highway will have one less obstacle to worry about, that is after the Commissioner of Police Chester Williams moved to shut down a police checkpoint that was erected in Hattieville Village amid consistent claims of extortion by cops.

According to the Commissioner, the decision to close the checkpoint comes on the heels of reports earlier this month that an officer had extorted US\$100 from someone. On Tuesday, Williams explained, "Just this morning I ordered that the checkpoint at Hattieville be taken down for the simple fact that we are getting too many complaints of extortion from that checkpoint. While we want to do road policing, it must not be at the expense of the Belizean people being shaken down by police officers at the

checkpoint."

Williams further commented that the persistent reports are an "embarrassment" to the Belize Police Department. In fact, Williams said that on that day there had been two complaints of extortion at the checkpoint. However, in one instance, the other individual chose not to file an official complaint on the matter.

"Certainly, it is frustrating. We try our best to rebrand the police to reform and provide better service to the people and certainly, not all police in Hattieville are like that. There is

a majority, and I can say 90% and over are honest police, but when you have that one in the bunch who is just so dishonest and does these sorts of things, it makes the entire department look bad," Williams indicated.


Williams said that while the checkpoint has been dismantled, he has instructed his officers to conduct highway patrols, but not so much on traffic violations. The highway patrols, according to Williams, will be more of an enforcement unit that deals with human trafficking, firearm trafficking, and human smuggling.

### **COMPOL** dismantle checkpoint Inflation Becomes the Leading **Global Concern in 2022**

appears It app-that corona has somehow become a concern of the past, at least for the time being. This perhaps speaks more to the rapid change of new, mounting crises rather than anything else, as the past months have seen droughts, famine, the war in Ukraine, an ensuing energy crisis and skyrocketing inflation.

This chart visualizes just how much can change in the space of two years. According to a survey of nearly 20,000 adults conducted by Ipsos, as many as 50 percent of respondents considered the pandemic a chief concern in January 2021. It has now fallen to a primary worry of only 12 percent - the joint lowest level since the coronavirus pandemic was added to the monthly survey. Inflation follows an opposite trend, however, with only 8 percent of adults stating it was a main concern in September 2020, rising to 40 percent saying it



was a worry last month. The countries where most people consider it a major concern for are Poland (67 percent), Argentina (65 percent), Turkey (56 percent) and the UK (56 percent).

The latest data shows that poverty and social inequality come second on the list of concerns as of September 2022, with around one in three respondents around the world selecting it. Hungary (46 percent), the Netherlands (46 percent), Brazil (42 percent), Indonesia (40 percent) and Thailand

(40 percent) recorded the highest share of people citing it as a top concern.

When asked whether respondents' countries were headed in the right direction or not, two thirds of adults said that their country was on the wrong track. Where Saudi Arabians (95 percent) and Indonesians (81 percent) gave the most positive answers, Peruvians (10 percent) and Argentinians (10 percent) were the least optimistic. Meanwhile, the UK and France saw the biggest drops (-9 p.p.).



## Bowen & Bowen Corporate Citizens Committee Plants Three Hundred Mangrove Seedlings

On October 3rd, 2022, Bowen & Bowen's Corporate Citizens Committee partnered with the Coastal Zone Management Authority & Institute (CZMAI) to plant 300 mangrove seedlings in the shallows behind Wesley College on Yarborough Road.

The project also aligns with the Coca-Cola System's Circular Seas initiative, which seeks to make a difference

in the communities where it operates by reducing waste in marine environments and improving the general health of our seas and the environment.

## Thousand-year-old Mayan Architecture unearthed all over Belize

Several ancient M a y a n architectures dating back over to 1000 years have been unearthed in several locations across Belize.

Merely one month after archaeologists from the Belize Institute of Archeology, alongside students from the University of Illinois Urbana-Champaign, discovered a Mayan settlement determined to be over 1000 years old, a new discovery has been made. A

paper published by Cambridge University details the findings of these archeologists.

According to the paper, 1,500-year-old Mayan structures were found at Ta'ab Nuk Na, the largest of 110 Maya sites submerged underwater in Paynes

were found at Ta'ab Nuk Na, the largest of 110 Maya sites submerged underwater in Paynes Creek National Park in Belize. The salt work site was discovered to also host large residential buildings along with three salt kitchens.

As evidenced by the hundreds of wooden posts that define the walls of classic Mayan poles and thatch wooden buildings, the structures were determined to be the remains of rare ancient architecture. In a statement from Dr. Elizabeth Sills, co-author of the study, said the structures were rare in nature due to the tendency of wood to decay in the tropical landscape of the Maya area.

Underwater archeologists used red flags to distinguish key points of interest, which were later determined to be the remains of the ancient buildings. Over 600 flags were placed during the excavation, which was later plotted digitally.

Examinations of the structures revealed that the buildings date back as far as the 6th century C.E. during the Late Classic Maya era. Salt kitchens and a large residence were later added to the structures in 650 C.E.

Mayan homes often worked to produce salt from their backyards, first ensuring that the household was adequately supplied before trading any surplus with neighboring communities. Being that salt was scarce in the inland where Mayan communities were growing, most communities were supplied with salt from salt kitchens on the coast. In total, around 24,000 people could have been supplied with salt from the sites at Ta'ab Nuk Na and elsewhere in the lagoon. Several artifacts were also discovered at the sites. These included a ceramic spindle whorl, cooking instruments, wood carving tools, incense burners, and a ceramic whistle.

These are among some of the remarkable discoveries unearthed in Belize within recent months.

In September, a Mennonite farming community in Central Belize was revealed to host the remains of collapsed Maya dwellings. Unassumingly, the settlement appeared as white mounds that pocket the landscape.

By observing the ceramics found within, it was determined that the dwelling dates back to AD 250 and AD 600. This period, known as the Classic period, is considered by many to be the height of Maya civilization, as this time marked the peak of largescale construction inscriptions, and demonstrated significant intellectual and artistic development across the Maya world.

### The Caribbea celebrates International day of the Girl child


As the world be serves International Day of the Girl Child, the organization Caribbean Women in Leadership commemorated the day by highlighting young women's accomplishments across the region.

International Day of the Girl Child, observed on October 11th, was declared by the United Nations in order to spotlight the accomplishment of young women worldwide and bring attention to the challenges they face regularly.

Caribbean Women in Leadership (CIWIL) is a non-partisan and independent, flagship networking organization committed to advancing women's transformational leadership, and increasing the numbers of women in leadership and decision-making in political and civic life. The organization took its platform to highlight some accomplished young women across the Caribbean.

According to data from the Caribbean Examinations Council (CXC) 2021 report, Girls in the Caribbean have been high performers at examinations such as the Caribbean Secondary Education Certificate (CSEC) Examination. The report also revealed that girls dominated 4 out of the 5 award categories. They were shown to have the most outstanding Performance in Humanities, Sciences, Technical and Vocational Studies, and Creative and Expressive Art.

CIWIL a 1 s o underscored the challenges young women face as a call to action for policymakers regionally. The Reporter spoke to Seraiah Romero, the communication, advocacy, and engagement officer, at CIWIL. Romero noted that one of the major



challenges to overcome is the lack of safety and protection for young girls. Gender-based violence continues to affect Caribbean households.

A study observed in five Caribbean nations indicated that across the countries, on average, nearly 46 percent of ever-partnered women aged 15-64 have experienced one or more of the four types of intimate partner violence (IPV) in their lifetime- (physical, sexual, psychological and/or economic violence).

Romero also mentioned the wage gap that still affects women all across the globe in several industries. Despite often excelling academically, females are still overlooked in their field of work in favor of their male counterparts. "When it comes to employment opportunities, young women struggle to find jobs within the field that they studied for that they would like to contribute to that will

pay them the same as men for doing the same work," Romero stated.

CIWIL affirms that in order to start closing some of these gaps and tackling the issues, awareness of the significance of women in the Caribbean needs to be spreadhighlighting the statistics of the success stories as well as the challenges they must first overcome. "We really call on policy and decision makers to re-examine the policy and laws that currently exist to protect women and girls as well as the effectiveness of them and to ensure that they are being reinforced adequately."

CIWIL invites all Caribbean nations to advocate for the safety and protection of girls as well making an effort to amplify their voices. They regularly host web conferences and online initiatives in order to regularly reinforce their commitment to seeing girls have equal opportunities in all spheres of life.

### Fiscal Policy Can Help People Rebound From Cost of Living Crisis


No vernments Jeonfront difficult trade-offs amid sharp increases in food and energy prices. Policymakers must protect low-income families from large real income losses and ensure their access to food and energy. But they must also reduce vulnerabilities from large public debts and, in response to high inflation, maintain a tight fiscal stance so that fiscal policy does not work at cross-purposes with monetary policy.

Food prices have been up by half since 2019 and supply disruptions have persisted in both food and energy markets. Higher prices threaten people's standard of living everywhere, prompting governments to introduce a variety of fiscal measures, including price subsidies, tax cuts, and cash transfers. We estimate the median fiscal cost of such measures at 0.6 percent of national gross domestic product, on top of pre-existing subsidies, among countries for which estimates were available.

Most governments face further pressure on public finances already strained by the pandemic. Rising inflation, weakening currencies, and climbing interest rates have led to surging credit spreads in many countries and higher interest expense going forward. Global public debt is projected to remain elevated at 91 percent of GDP in 2022—after receding from a historic high in 2020—and remains about 7.5 percentage points higher than prepandemic levels. Low-income countries are particularly vulnerable: nearly 60 percent of the poorest economies are in debt distress or at high risk of it.

In our latest Fiscal Monitor, we discuss how policymakers can approach these tradeoffs, helping people bounce back from the current crisis and better cope with future challenges.

Food and energy response



Facing high debt levels and rising borrowing costs, policymakers should prioritize targeted support through social safety nets to the most vulnerable people. In some countries, this might entail providing discounts on utility bills (for basic usage) to vulnerable low- and middle-income families. Allowing energy prices to adjust is crucial to preserving broader incentives to curb energy use and increase supply. Faced with long-lasting supply shocks and broad-based inflation, governments should not attempt to limit price increases through price controls, subsidies, or tax cuts. Such a move would be costly to budgets and ultimately ineffective. With limited resources, many low-income countries will need greater global efforts in humanitarian assistance and emergency financing.

financing.

In a time of high inflation, policies to address high food and energy prices should not add to aggregate demand. Demand pressures force central banks to raise interest rates even higher, making it more expensive to service government debt. A tightening fiscal stance sends a powerful signal that policymakers are aligned in their fight against inflation.

#### Fostering economic resilience

Our report highlights that governments need to build resilience over time to a range of adverse shocks. The pandemic and the global financial crisis, beyond country-specific natural disasters and other

adverse events, have shown that governments must prepare for rainy days. Building fiscal buffers gradually would eventually allow policymakers to respond swiftly and flexibly to crises.

Several fiscal tools that have proved useful during the pandemic can be made part of a more permanent toolkit, depending on countries' capacity and available fiscal space. Job-retention schemes, for example, proved effective during the pandemic by stabilizing more than 40 percent of individual income loss in the European Union. Exceptional financial support to companies can prevent widespread bankruptcies. But such support should be reserved for severe crises as it exposes governments to sizable fiscal risks.

More generally, social safety nets help people bounce back from unemployment, sickness, or poverty, making them more resilient to a broad set of challenges. Such systems can be made readily scalable and better targeted with the help of digital technology.

We have seen how major global crises during the past decadeand-a-half have led to innovative and forceful fiscal responses, against the backdrop of rising debt and constrained monetary policy. Countries should rethink the role of fiscal policy in a shock-prone era—how it can better buffer against losses during crises and build resilience—and learn from experiences across the world.

### 'Love hormone' oxytocin may help mend broken hearts (literally), lab study suggests

Oxytocin, sometimes called the "love hormone," may help heal broken hearts — literally. In a new study of zebrafish and human cells, scientists found that the

brain-made hormone may help heart tissue regenerate after injury and, in theory, could someday be used in the treatment of heart attacks, according to the researchers.

Because the new study was conducted in fish tanks and lab dishes, however, this theoretical treatment is still far from realization.

Oxytocin has been nicknamed the "love" or "cuddle" hormone for its known role in forging social bonds and trust between people, and its levels often rise when people cuddle, have sex or orgasm. However, the so-called love

hormone also serves many other functions in the body, such as triggering contractions during childbirth and promoting lactation afterward. Oxytocin also helps guard the cardiovascular system from injury by lowering blood pressure, reducing inflammation and diffusing free radicals, a reactive byproduct of normal cell metabolism, according to a 2020 review in the journal Frontiers in Psychology.

The new study, published Friday (Sept. 30) in the journal Frontiers in Cell and Developmental Biology(opens in new tab), highlights yet another potential benefit of oxytocin: At least

studies suggest that after an injury, like a heart attack, a subset of cells in the heart's outermost membrane, called the epicardium, don a new identity. These cells migrate down

into the layer of heart tissue where muscles reside and transform into stem-like cells, which can then turn into several heart cells types, including cardiomyocytes.

This process has largely been studied in animals and there's some evidence to suggest that it may also occur in adult humans. Unfortunately, if the process does occur in people, it seems to unfold too inefficiently and in too few cells to result in meaningful tissue regeneration after a heart attack, the study authors said in a statement(opens in new tab). By somehow encouraging more epicardial cells to

morph into cardiomyocytes, the authors theorize, scientists could help the heart rebuild itself after injury.

The study authors found they could jumpstart this process in human cells in a lab dish by exposing them to oxytocin. They also tested 14 other brain-made hormones, but none of the others could coax the cells into the desired stem-like state required to make new cardiomyocytes, according to the statement.

The team then conducted follow-up experiments in zebrafish, a fish in the minnow family known for its impressive ability to regenerate tissues in its body, including the brain, bones and heart. The team found that, within three days of a cardiac injury, the fishes' brains began pumping out oxytocin like mad, producing up to 20 times more than they had prior to the injury, the team found. The hormone then traveled to the heart, plugged into its receptors and kicked off the process of transforming epicardial cells into new cardiomyocytes.

These experiments provide early hints that oxytocin may play a key role in heart repair after injury, and by boosting its effects, scientists could develop new treatments to improve patients' recovery after heart attacks and reduce the risk of future heart failure, the authors concluded. These treatments might include drugs that contain oxytocin or other molecules that can plug into the hormone's receptors.

"Next, we need to look at oxytocin in humans after cardiac injury," senior author Aitor Aguirre, an assistant professor in the Michigan State University Department of Biomedical Engineering, said in the statement. "Overall, pre-clinical trials in animals and clinical trials in humans are necessary to move forward."



in zebrafish, the hormone helps the heart replace injured and dead cardiomyocytes, the muscle cells that power heart contractions. Early results in human cells hint that oxytocin could stimulate similar effects in people, if delivered with the right timing and dose.

The heart has a very limited ability to repair or replace damaged or dead tissue, the study authors noted in their report. But several





Inflation could, yet again, prove more persistent, especially if labor markets remain extremely tight.

Finally, the war in Ukraine is still raging and further escalation can exacerbate the energy crisis.

Our latest outlook also assesses the risks around our baseline projections. We estimate that there is about a one in four probability that global growth next year could fall below the historically low level of 2 percent. If many of the risks materialize, global growth would decline to 1.1 percent with quasi stagnant income-per-capita in 2023. According to our calculations, the likelihood of such an adverse outcome, or worse, is 10 percent to 15 percent.

Cost-of-living crisis

Increasing price pressures remain the most immediate threat to current and future prosperity by squeezing real incomes and undermining macroeconomic stability. Central banks are now laser-focused on restoring price stability, and the pace of tightening has accelerated sharply.



tightening. Under-tightening would further entrench inflation, erode the credibility of central banks, and de-anchor inflation expectations. As history teaches us, this would only increase the eventual cost of bringing inflation under control.

Over-tightening risks pushing the global economy into an unnecessarily severe recession. Financial markets may also struggle with overly rapid tightening. Yet, the costs of these policy mistakes are not symmetric. The hard-won credibility of central banks could be undermined if they misjudge yet again the stubborn persistence of inflation. This would prove much more detrimental to future macroeconomic stability. Where necessary, financial policy should ensure that markets remain stable. However, central banks need to keep a steady hand with monetary policy firmly focused on taming inflation.

Formulating the appropriate fiscal response to the cost-of-living crisis has become a serious challenge. Let me mention a few key principles. First, fiscal policy should not work at cross-purpose with monetary authorities' efforts to bring down inflation. Doing so will only prolong inflation and could cause serious financial instability, as recent events illustrated.

Second, the energy crisis, especially in Europe, is not a transitory shock. The geopolitical realignment of energy supplies in the wake of the war is broad and permanent. Winter 2022 will be challenging, but winter 2023 will likely be worse. Price signals will be essential to

curb energy demand and stimulate supply. Price controls, untargeted subsidies, or export bans are fiscally costly and lead to excess demand, undersupply, misallocation, and rationing. They rarely work. Fiscal policy should instead aim to protect the most vulnerable through targeted and temporary transfers.

Third, fiscal policy can help economies adapt to a more volatile environment by investing in productive capacity: human capital, digitalization, green energy, and supply chain diversification. Expanding these can make economies more resilient to future crises. Unfortunately, these important principles are not always guiding policy right now.

Effects of a strong dollar

For many emerging markets, the strength of the dollar is a major challenge. The dollar is now at its strongest since the early 2000s, although the appreciation is most pronounced against currencies of advanced economies. So far, the rise appears mostly driven by fundamental forces such as tightening US monetary policy and the energy crisis

The appropriate response in most emerging and developing countries is to calibrate monetary policy to maintain price stability, while letting exchange rates adjust, conserving valuable foreign exchange reserves for when financial conditions really worsen.

As the global economy is headed for stormy waters, now is the time for emerging market policymakers to batten down the hatches.

Eligible countries with sound policies should urgently consider improving their liquidity buffers, including by requesting access to precautionary instruments from the Fund. Countries should also aim to minimize the impact of future financial turmoil through a combination of preemptive macroprudential and capital flow measures, where appropriate, in line with our Integrated Policy Framework.

Too many low-income countries are in or near debt distress. Progress toward orderly debt restructurings through the Group of Twenty's Common Framework for the most affected is urgently needed to avert a wave of sovereign debt crisis. Time may soon run out.

The energy and food crises, coupled with extreme summer temperatures, are stark reminders of what an uncontrolled climate transition would look like. Progress on climate policies, as well as on debt resolution and other targeted multilateral issues, will prove that a focused multilateralism can, indeed, achieve progress for all and succeed in overcoming geoeconomic fragmentation pressures.


### World's Number One Best Selling Book - The Bible

#### received the first part of his petition but **Patrick Faber Strikes Again?**

Ceveral months Dago, UDP Collet Representative Patrick Faber had vowed to stay out of the spotlight and seek counseling following a slew of domestic abuse allegations, but this week another recent video of Faber engaged in a similar scenario made its way on social media.

The repeated actions of the former UDP Party Leader did not escape the prying eyes of the UDP's National Organization for Women who issued a short press release expressing their "firm no tolerance of genderbased violence." The organization says that the video shows evidence of domestic violence being witnessed by a child, which is unacceptable and is in fact everyone's concern though it is between two adults.

"We are even more appalled that in this instance and for a second time, the person involved is an elected official whom many of our young people look up to. We appeal to the individuals involved to seek help as this issue can possibly lead to further and more severe consequences," indicated the release.

The video which was reportedly taken in May of this year shows Faber in what appears to be a scuffle with a woman. The video, which also happens to be part of a political ad, also shows a child later identified as Faber's daughter, at the edge of the frame witnessing the ordeal.

The video was recorded by the child's mother Nickiesha

Polanco who took to social media shortly after the ad aired and wrote:

"The incident that is circulating on social media of a most recent domestic issue involving my daughter's father and his fiancé; in the presence of my child during one of our most recent trips home this past summer is very frightening and regrettable. I too have lived through my nightmare with the said man and that is why I decided to step away, for my daughter's safety and mine."

Faber did not waste any time responding to Polanco's post. He accused her of taking the video and selling it to his political enemies. He further accused her of being jealous that he chose another woman instead of her.

In January of this year, Faber had stepped down from his post as party leader amid calls for his resignation, following an incident in which he had allegedly assaulted his, then, fiancée and damaged a laptop belonging to her. While the victim had later requested that the charges be dropped against Faber, the damage to Faber's political career had already been done, resulting in him leaving the country to access therapy.

Faber had only just started to attend House Meetings in July of this year and appeared to have been gaining political mileage once more despite being recently kicked out of the UDP Central Executive and then rejected from running as a Standard Bearer for the Collet Constituency.

### Monkey River locals expect the worst and hope for the best

For decades, Monkey River residents have battled against the erosion plaguing their shores. Recent flooding has whisked yet another house to sea, but the people say they have come to anticipate such events.

Eloydia Cuevas, the chairperson of Monkey River village, told The Reporter that this is not the first house lost to the waters creeping onto the land. "Honestly, it was expected. For years, we've been dealing with this issue, Cuevas recalled, while underscoring the multitude of houses residents have been forced to abandon lest end up living with the sea under their doorsteps.

In the past, residents have expressed their pressing need for assistance but feel that those calls have landed on deaf ears. Small conservation efforts have been put in place previously; however, none has

shown any lasting results. "Tires and tubing were placed on the shoreline, which did help but those were only temporary fixes," Cuevas explained. She also spoke of families partnering to create a barrier of sandbags in their attempt to remedy the situation.

The residents believe that Monkey River can be restored if the right initiatives were enacted. In addition to the land erosion concern, the inaccessibility of the road to Independence village has been a mounting issue. In light of recent weather conditions, people needing to travel to Independence have found themselves

unable to do so.

This matter is a pressing issue as noted by Cuevas, who recalled the instances in which the van responsible for taking children to school was unable to make the journey to the village, and NEMO was contacted for assistance. "We have children that need to get to school. At times,

children cannot make it back into town. Phone calls and tough decisions were made by parents, with some children being forced to spend the night in Independence."

Cuevas expressed her disquiet about the challenges villagers must face to receive a high school education. She states that it shouldn't be

this difficult to get to school. Although the village is small, relocating is not an option. Being that Monkey River is a fishing village, many residents depend on it to make their livelihood. "These are these people's lives. They cannot just pick up and leave everything. There is a future here."

### San Jose Palmar fetes Indigenous Peoples' Resistance Day

Unbeknownst to most Belizeans, the history of northern Belize was not always peaceful, and the Yucatec Maya defeated the British at the Battle of San Pedro Yalbac in western Orange Walk district in 1866.

The British Army torched many of their villages in 1867, but they continued to resist European occupation of their land for the next 60 years, until the British Honduras Company forcibly relocated them in 1939.

The colonial administration granted the remnants, some 200 villagers led by their Alcalde Maximo Perez, a piece of land by where they were resettled in what became the village of San Jose Nuevo Palmar in Orange Walk district. In celebration of Indigenous Peoples Resistance Day, observed worldwide on October 12, the Ministries of Human Development, Families and Indigenous Peoples and Education and Culture joined the Yalbac descendants and the Northern Maya Association of Belize in hosting the 21st Fiesta del Pueblo in the village on Sunday, October 9.

The Yucatec Maya

contributed greatly to the development of northern Belize, cited Minister of State Hon. Elvia Samos Vega, not least of which was they brought sugar cane, which founded the sugar cane industry, which became the engine that helped develop the Belizean economy in the 1960's through the 1980's. She also acknowledged the contributions of all indigenous peoples including the Mopan Maya, Quetchi Maya and the Garinagu to Belize's ethnic and cultural diversity and knowledge of

traditional medicine. Education is important to preserve our history and cultural heritage for future generations, noted Chief Education Officer Yolanda Gongora, deputizing for Minister of Education Hon. Francis Fonseca. Other guests included Minister of State Hon. Ramon Cervantes and Taiwan's Ambassador to Belize, H.E. David Kuan-Chou Chien

Arturo Cantun, a cofounder of the Fiesta, recognized the efforts of Doña Genara Cano, Teodora Orellana, Don Margarito Medina, Hugo Carrillo Cocom, Felicita Cantun, Roy Rodriguez, Don Gary Cantun, Ms. Libertad Cal, Javier Magaña and Ms. Helaria Uh in preserving the Maya's language, art, music, dance, traditional dress, cuisine, religious beliefs and cultural values. Chief Executive Officer Tanya Santos-Neal presented the awards.

The festival began with the children of the Juul Kin (Sun Rays) group singing the national anthem in Yucatec Maya.

The fiesta continued with traditional Mayan cultural dances, such as the Deer Dance, the Bottle Dance and Las Chiapanecas, performed by Maya Naay group of Yo Creek Village and the Folkloric Ballet Group of Quintana Roo, and a demonstration of the traditional Mayan ball game Pok-ta-pok, in which the solid, natural rubber ball may only be struck with the hip. The Ek-Balam team of Yo Creek are the three-time world Pokta-pok champions of the Mundo Maya region, and will host the next pok-ta-pok world cup in Belize in 2023. Visitors were also treated to many Yucatecan gastronomic delights such as tamales and cochinito pibil tacos.

## Taiwan's participation can strengthen international cooperation to fight transnational telecommunication fraud in the postpandemic era

Fraud is disrupting people's livelihoods in the postpandemic era

The internet is very much part of A daily life in the postpandemic world. Working, studying, shopping, and conducting other transactions online have become commonplace. But the digital financial services that have developed from these activities are an easy target for criminal organizations and have also made investigating crime more complicated for the police. In 2021, Taiwan reported fraudrelated losses of NT\$5.61 billion (equivalent approximately to US\$186 million), indicating that fraud has seriously damaged national economic development. There is little doubt that fraud poses a formidable challenge to countries worldwide.

In recent years, fraud has become more diverse and sophisticated and scammers are working in new and constantly evolving ways. Schemes involving cryptocurrency—recently a hot commodity—have inflicted heavy losses on victims. When Taiwan's police investigate cases, they often encounter difficulties arising from the fact that servers, recipient accounts, and cryptocurrency exchange platforms used by perpetrators are based overseas. This prevents officers from stopping the transfer of money in time to help the victims and makes it more difficult to track down suspects.

The inflow of profits from fraud and other illegal activities involves money laundering, tax evasion, and other crimes that undermine domestic financial regulatory systems and erode the sovereign authority of governments. Police cooperation between Taiwan and other countries would help reduce the number of fraud cases and contribute to the administrative efficiency of governments worldwide.

### International cooperation is needed to combat the use of virtual currencies for money laundering

Virtual currencies are a high-risk-highreward commodity. They have grown increasingly popular in investment markets. As the average person does not fully understand how virtual currencies work, these investments have become a common instrument of organized fraud. Taiwan police have recently discovered that money laundering by criminal groups using virtual currencies mostly involves proceeds from investment fraud. Victims are lured into registering with a fake investment platform and when they try to withdraw funds after making a profit, the customer service system—operated by the criminal group requires them to pay additional taxes of 10 to 20 percent before the withdrawal can be approved. Even if the payment is made, the criminal group continues to fabricate further demands that the account be replenished in order to cover, for example, transaction fees.

Criminal organizations have shifted their tactics from buying mule bank accounts to using virtual currency wallets, thus lowering the risk of police detection when funds are withdrawn. The gangs open phony accounts with virtual currency exchanges, where identity verification procedures are relatively relaxed. Once a victim makes a deposit into a designated account, the scammers quickly transfer the money multiple times, eventually moving it to a cold wallet. It is then switched



to another exchange where it is converted into legal tender. Crypto wallets that do not require user authentication and have no upper limit on transactions are a convenient tool for money laundering. The victim, perpetrator, and location of the crime are usually in different countries. Thus, transnational cooperation is needed to effectively crack down on the common practice of concealing illegal gains and converting them into legal assets.

Taiwan's police strive to protect victims of organized human trafficking

Anticipating that the number of job seekers would increase due to involuntary unemployment driven by the pandemic, criminal organizations set up call centers in various parts of the world and recruited people on a large scale through online advertising. The scammers used attractive slogans like "easy job" and "fast financial freedom" and promised stable and legal employment in other countries. Victims only discovered after arriving that the jobs involved fraud or were not what they expected. Some even had their passports confiscated, were deprived of their freedom, and were beaten or sold to other unlicensed businesses if they refused to comply. If they asked to quit, they were forced to pay exorbitant fines or threatened with organ removal to compensate the gangs.

Human trafficking is a serious issue that needs to be addressed by the global community. Fraud rings take advantage of the convenience of the internet to recruit people of different nationalities through multiple channels to work in scam call centers around the world. Taiwan police have long spared no effort to crack down on this type of transnational crime. This year, they have received reports of Taiwanese citizens being held against their will and forced to engage in fraudulent activities in Cambodia, the Philippines, the United Arab Emirates, and other countries by illegal organizations set up by Chinese nationals. International cooperation is urgently needed to rescue the victims and fight such crimes.

In 2021, Taiwanese and Vietnamese police jointly cracked down on a fraud ring in Taiwan that was forcing Vietnamese migrants who had overstayed their visas to engage in scams targeting their fellow compatriots. The racket earned the criminals VND3.29 billion (equivalent to about US\$140,000). In cooperation with other foreign law enforcement agencies, Taiwan's police have uncovered several cases of organized crime outside Taiwan linked to cross-border fraud and human trafficking. They worked with Montenegro in 2020 and with Turkey in

2021 to clamp down on organized crime involving perpetrators, victims, and locations in multiple countries. In the joint operation with Montenegro, 92 suspects were arrested for defrauding more than 2,000 victims of a total of NT\$632.78 million (equivalent roughly to US\$21 million). These cases not only underscore the importance of cooperation among countries to combat crime but also highlight the need for concerted efforts to protect human dignity and values.

Taiwan's

contribution will benefit the world Taiwan has a high regard for the rule of law and human rights. The Constitution of the Republic of China (Taiwan) upholds the ideal that national sovereignty resides with the people and explicitly provides for the protection of people's rights and freedoms. The government strictly prohibits any action that infringes on the rights of others. Transnational crime often involves multiple countries and areas, which can hinder investigations. In the postpandemic world, criminal tactics will continue to evolve and new methods will emerge. In investigating new forms of criminal activity, experience is invaluable. Taiwan is willing to share its experience in solving crimes. Today, telecommunications and cyber fraud are conducted across borders and transnational crime rings are organized and departmentalized. This poses a challenge to the sovereignty of nations and undermines livelihoods, economies, and law and order. Taiwan is keen to exchange intelligence with partners and assist other countries in staving off threats from overseas and combating organized crime within their borders.

Police officials are entrusted with the heavy responsibility of maintaining law and order. Their top priority is to protect people's lives and property. Given that crime has taken on increasingly diverse forms, police are facing even greater challenges. To fight modern crime, law enforcers need a firm understanding of the latest criminal developments so that they can prepare for the future and be ready to respond decisively. Looking ahead, Taiwan's police will continue to work with partners worldwide. No place should be overlooked in fighting the pandemic or tackling crime. The international community can count on Taiwan.



## Westline Bus Company issued with pollution abatement notice

Westline Bus Company, which has its headquarters set up in Benque Viejo Town, has been issued with a Pollution Abatement Notice, for an oil spill that occurred on Wednesday which is said to have originated from their compound on George Price Boulevard and resulted in the contamination of a nearby drain and surrounding areas.

On Wednesday, October 12, personnel from the Department of the Environment were summoned out to Benque Viejo Town by concerned residents to assess the oil spill. The team moved quickly, and with the combined efforts of employees of the bus company was able to contain the oil spill to a drain that it had leaked into.

The Ministry said that the team will continue to oversee the clean-up activities in the upcoming days. In the interim, the department "has issued a pollution abatement notice to the company to ensure the necessary measures are implemented to avoid further environmental impacts, and subsequently seek legal advice in the prosecution of the offense and/or levying of applicable penalties under the EPA."

According to the Department of the Environment, an inspection of the site had revealed that a container having a capacity of about 1,100 gallons, and storing waste oil had ruptured, resulting in the oil spill. The department said that waste oil, which is classified as a hazardous substance under the Environmental Protection Act (EPA), was stored on a slope causing it to run off into a drain leading to the Mopan River. While an assessment is still ongoing, the department



indicated that there is no evidence at this time to suggest that the oil has entered the Mopan River, but that that scenario is possible once the floodwaters recede

The department also claimed that the exact quantity of the oil spill is yet to be determined since the company has still not given any record of the amount of oil that was stored in the container. They also pointed out that Westline Bus Company has still not reported the spill.


The Benque Viejo Town Council has since come out to condemn what they refer to as the "negligent disposal of oil waste" by the company which they reiterated was avoidable. The Council indicated that

the spill has made its way into Coffin Creek which empties out into the Mopan River and called on the company to take immediate action to rectify the damages and clear the waste from the waterway.

On a similar note, the Ministry of Sustainable Development, Climate Change, and Disaster Risk Management issued a release reminding the public that chemicals such as industrial chemicals, pesticides, and other hazardous substances should be stored on high ground away from floodwaters. They reiterated the need for chemicals to be properly stored using best practices and standard requirements such as segregated storage, tightly sealed containers, and containment bunds.

## WWF's Living Planet Report reveals a devastating 69% drop in wildlife populations on average in less than a lifetime

(13 October 2022) - Monitored wildlife populations - mammals, birds, amphibians, reptiles and fish - have seen a devastating 69% drop on average since 1970, according to WWF's Living Planet Report (LPR) 2022.

The report highlights the stark outlook of the state of nature and urgently warns governments, businesses and the public to take transformative action to reverse the destruction of biodiversity.

With its biggest dataset yet, featuring almost 32,000 populations of 5,230 species, the Living Planet Index (LPI), provided within the report by ZSL (Zoological Society of London), shows it is within tropical regions that monitored vertebrate wildlife populations are plummeting at a particularly staggering rate. WWF is extremely concerned about this trend given that these geographical areas are some of the most biodiverse in the world. In particular the LPI data reveals that between 1970 and 2018, monitored wildlife populations in Latin America and the Caribbean region have dropped by 94% on average.

In less than a lifetime, monitored freshwater populations have fallen by an average of 83%, the largest decline of any species group. Habitat loss and barriers to migration routes are responsible for about half of the threats to monitored migratory fish species.

Commenting on the findings, Marco Lambertini,

Director General of WWF International, said: "We face the double emergencies of human-induced climate change and biodiversity loss, threatening the well-being of current and future generations. WWF is extremely worried by this new data showing a devastating fall in wildlife populations, in particular in tropical regions that are home to some of the most biodiverse landscapes in the world."

World leaders are due to meet at the 15th Conference of Parties to the Convention of Biological Diversity (CBD COP15) this December for a once-in-a-decade opportunity to course-correct for the sake of people and the planet. WWF is advocating for leaders to commit to a 'Parisstyle' agreement capable of reversing biodiversity loss to secure a nature-positive world by 2030.

"At the COP15 biodiversity conference this December, leaders have an opportunity to reset our broken relationship with the natural world and deliver a healthier, more sustainable future for all with an ambitious naturepositive global biodiversity agreement," said Dr Lambertini. "In the face of our escalating nature crisis, it's essential this agreement delivers immediate action on the ground, including through a transformation of the sectors driving nature loss, and financial support to developing countries.'

Some of the species' populations captured in the LPI include the Amazon pink river dolphin population, which saw populations plummet by 65% between 1994 and 2016 in the

Mamirauá Sustainable Development Reserve in the Brazilian state of Amazonas; the eastern lowland gorilla, whose numbers saw an estimated 80% decline in DRC's Kahuzi-Biega National Park between 1994 and 2019; and South and Western Australian sea lion pups, which plunged by two-thirds between 1977 and 2019.

Dr Andrew Terry, Director of Conservation and Policy at ZSL, said: "The Living Planet Index highlights how we have cut away the very foundation of life and the situation continues to worsen. Half of the global economy and billions of people are directly reliant on nature. Preventing further biodiversity loss and restoring vital ecosystems has to be at the top of global agendas to tackle the mounting climate, environmental and public health crises."

Around the world, the report indicates that the main drivers of wildlife population decline are habitat degradation and loss, exploitation, the introduction of invasive species, pollution, climate change and disease. Several of these factors played a part in Africa's 66% fall in its wildlife populations over the period, as well as Asia Pacific's overall 55% drop.


The LPR report makes clear that delivering a nature-positive future will not be possible without recognising and respecting the rights, governance, and conservation leadership of Indigenous Peoples and local communities around the world.

Flor Delicia Ramos Barba said she has felt the loss of nature in the Indigenous community of Santo Corazon in Santa Cruz, Bolivia, where she lives. "The roar of the jaguar could be heard near the community three years ago, but not anymore. Compared with my childhood, I've witnessed a big difference. The animals in the community are now gone. We also feel this lack in the rivers. The people used to go fishing to support their families, but now there are no fish. Tree species have also been disappearing.

"As a community we have become aware of the difficulties that come our way year after year. The conservation of our territory is important to us."

The report argues that increasing conservation and restoration efforts, producing and consuming food in particular more sustainably, and rapidly and deeply decarbonising all sectors can mitigate the twin crises. The authors call on policymakers to transform economies so that natural resources are properly valued.

"The Living Planet Report contains shocking figures directly related to our interlinked climate and biodiversity crises and in response we must see transformative systems change if we're to halt and reverse nature loss and secure a flourishing future for people and nature," said Dr Lambertini. "Government leaders must step up at COP15. The world is watching."



## Latin America Faces a Third Shock as Global Financial Conditions Tighten


As Latin American c o u n t r i e s continue to grapple with the effects of two previous shocks, the pandemic and Russia's invasion of Ukraine, they face a third shock: the tightening of global financial conditions.

Growth momentum is currently positive, reflecting the return of service sectors and employment to prepandemic levels, and the overall support of favorable external conditions—high commodity prices, strong external demand and remittances, and rebounding tourism. This has led to several upward revisions to growth this year.

But financing is becoming scarcer and costlier as major central banks raise interest rates to tame inflation. Capital inflows to emerging Rising borrowing costs

markets are slowing and external borrowing costs are increasing. Domestic interest rates in emerging markets are also rising as their central banks are hiking rates to battle inflation as well, but also because of reduced investors' appetite for risker assets.

For Latin America, these factors result in a deceleration in activity as higher borrowing costs weight on domestic credit, private consumption, and investment.

Earlier this year, surging commodity prices and solid growth momentum helped offset the effects of tighter global financial conditions, as investors were attracted by a region that hosts major commodity exporters amid global needs for food and energy supplies. But higher interest rates are pushing commodity prices down as the global economy decelerates, reducing their cushioning effect. The slowdown may also reduce exports, remittances, and tourism to the region.

Uncertainty about global interest rates and whether inflation can be brought back under control smoothly—a so called 'soft landing'—means spikes in volatility and investor risk aversion are also possible. In other words, the transition to higher global interest rates may be bumpy.

#### Solid growth but deceleration

A mid positive surprises in activity, we have upgraded our growth projection for Latin America and the Caribbean this year to 3.5 percent from 3 percent in July.

But with the changing winds ahead, growth next year is poised to decelerate more rapidly than we projected in July, slowing to 1.7 percent.

Commodity exporters—South American countries, Mexico and some

Caribbean economies are likely to see their growth rates halved next year, as lower commodity prices amplify the impact of rising interest rates.

The economies of Central America, Panama and the Dominican Republic will also slow as trade with the United States and incoming remittances weaken, though they will benefit from lower commodity prices. Tourism-dependent Caribbean economies will continue recovering. albeit slower-thananticipated in July amid weaker tourism prospects.

#### Fighting stubborn inflation

Despite slowing growth, Latin America will continue facing high inflation for some time.

The swift response of major central banks in the region, which hiked interest rates ahead of other emerging market and advanced economies, will help bring down inflation, but this will take time as monetary policy needs to tame domestic demand to exert downward pressure on prices.

Also, price pressures have recently broadened, affecting items of the consumption baskets beyond food and energy. This has been the case in Brazil, Chile, Colombia, Mexico and Peru, where inflation recently reached a two-decade high of 10 percent and is testing the hard-won credibility of inflation targeting frameworks.

We have, therefore, raised our inflation forecasts. Price increases for those five countries will reach around 7.8 percent by year-end and remain elevated at about 4.9 percent—still above central banks' tolerance bands in most cases—by the end of next year.

#### Healthy banks, debt risks

Rising global interest rates will also test the resilience of private and public balance sheets. The region's generally healthy banking systems mitigate the risk of financial distress, and regulation and supervision have improved in many countries.

But pockets of vulnerabilities remain. For example, corporate debt has grown considerably over the last decade, especially outside the banking system. Monitoring these vulnerabilities will be key to identify potential sources of stress and take early action.

While the region's high levels of international reserves and strong central bank credibility will help mitigate the impact of tighter financial conditions, rising borrowing costs will test public finances through higher interest payments, as public debt and financing needs remain elevated.

#### **Balancing** act

Central banks in the region have acted fast and kept long-term inflation expectations anchored.

Going forward, monetary policy should stay the course and not ease prematurely. Setting monetary policy amid high uncertainty is challenging, but having to restore price stability later if inflation becomes entrenched would be very costly.

Fiscal policy should focus on rebuilding policy space, where needed. This will require reining in public spending, improving the design of the tax systems, and strengthening fiscal frameworks to secure sustained discipline.

With dire social needs in the region, however, policies to reduce debt and deficits can only be effective and durable if they are inclusive—that is, if they protect the poor.

Even where fiscal space exists, fiscal policy should also go hand in hand with monetary policy, focusing on supporting vulnerable groups, especially while high inflation persists and growth weakens, but without fueling domestic demand. This will require careful calibration to offset spending measures to protect the poor.

Getting this balancing act right is key to achieving inclusive and sustainable growth, and this is the best way to build resilience against future shocks.


