

Cattle exports 'beef up' local meat prices

The price of beef has increased due to an ongoing price war

between Mexican and Guatemalan cattle buyers that was triggered

Ingreased demand is pushing up prices by the Mexican

government's recent decision to remove the import duty for select export commodities.

Mexican President Andrés Manuel López Obrador (AMLO), on May 16, 2022, issued a Presidential Decree to exempt 66 tariff items from import duties. The list—which includes live animals—

covers cattle and meat products. The resulting hike in cross-border demand and competition has left a handful of local meat processors feeling the effects of the price increase.



t has come as a surprise to many that the Brads Gaming Group Limited, the group which hosts the government lottery, has not been paying the relevant lottery tax, which for most other lotteries is 12.5% its earnings. However, back in 2011, via *Statutory Instrument No. 88 of 2011*, this particular lottery was listed as "exempt from lottery taxes."

The Briceño Government has been making allowances for businesses devastated by the COVID pandemic which has plagued the economy of Belize for the past 30 months. But it expects those who are able to make the payments to do so. As far as we can tell, Brads Gaming Group is a privately owned company that managed to secure a sweetheart deal under the Barrow administration.

Of course, with the advent of Statutory Instrument No. 51 of 2022 (or The Lotteries Control Amendment Regulation, 2022), the Briceño administration has opted to bring this "sweetheart deal" to an end. The new law reads:

"The principal Regulations are amended in the Fourth Schedule...in item 6 [Government Lottery] by deleting the words 'exempt from lottery taxes' and substituting the words '12.5% (monthly on gross income)." This change has motivated the company to announce that it has "filed an action in the Supreme Court seeking to quash Statutory Instrument 51 of 2022."

Like the casinos, it pays a specified lump sum of money each year for its license to operate this money machine.

At the time the deal was made, the yearly fee appeared to be adequate and fair. But this company and the lotteries it manages have grown to be

Cabinet Walks Back on Taxing Entertainers, For Now

Government referred to the House Committee Meeting which was held in Belmopan on Monday where stakeholders, including a handful from the entertainment industry, the Belize Chamber of Commerce and Industry, as well as the Belize City Council had all presented and voiced their concerns.

In their release, the

As a result, the Government noted, "Noting the fragile state of the entertainment industry caused by the COVID-19 pandemic, Cabinet agreed to defer any fee for local entertainers while consultations continue with stakeholders in the entertainment industry."

Cabinet also promised that they will also consult with the relevant stakeholders to develop incentives for the creative sector. They also said that all other recommendations that were presented and highlighted at the House Committee Meeting on Monday will be "duly considered" before the revised bill is presented to the House of Representatives for consideration. While we attempted to get a comment from the chief executive officer in the Ministry of Local Government, Valentino Shal, on this latest development, he told our newsroom via WattsApp: "That [referring to the Cabinet statement] is the official position. Nothing else to add." Earlier this week, however, following the House Committee Meeting, Shal had told us that he was pleased to see the various stakeholders using the medium available to address any concerns that they were having regarding the Bill. Shal said that several key points were raised by members of the entertainment sector as well as others who were present. "We want to assure them that we will take their concerns into account and these will be addressed," he said. While the Bill had covered several aspects of the new trade license regime, entertainers were primarily in opposition to Schedule VII, which outlined the fee for concerts, local onstage performers, and entertainers. That fee not exceeding \$200 would have been charged per event and would not have been applicable to free and charitable performances. The Government argued that the Trade License Board would use the \$200 fee as a guide to declaring fees, the final of which would be made after the respective boards determine the most appropriate quantum, which may be less.

The entertainers, however, said that they were not consulted in the first place and that the amount per performance was outrageous, since the fee is not conducive to the type of income that is being made in the entertainment industry.

development of livestock in Belize, explained the higher prices had nothing to do with shortages.

"I don't believe that there is a shortage, it is more of a price war that is going on," he shared. "Please note that Mexico recently waived the 15% tariff and there is more interest from other companies coming into Belize to look for the beef that we have. The Guatemalans, after hearing of the waiving of that tariff, have increased their prices from \$2.10 to \$2.30 and in some instances to \$2.35. ... The local meat processing facilities are paying ... about \$2.15 or \$2.10. So that is basically what the situation is; it's not really a shortage. We are self-sufficient in beef."

Esquivel further explained that obviously the cattle producers will do business with whoever is paying more for their products, which will translate to more money in their pockets, even in the midst of price increases in grains and other products needed to sustain their livestock.

While Esquivel noted that the ministry has a responsibility to ensure that there is food security in the country, he said that they cannot manage everything. Esquivel said that the Ministry will keep an eye on the situation as it develops over time; however, he added that the local meat processing facilities have three options. They could get in on the competition, wait until the prices fall back down, or reestablish contract agreements with local farmers.

Mindy Garcia, general manager of the Belize Livestock Producers Association, also clarified that the ministry has also c o m m u n i c at e d with the different livestock farmers and processing facilities across the country, all of whom have reported that there is no shortage.

"We have always mentioned that we have enough beef to supply to our country and maintain for our local consumption," reiterated Garcia. "There has been a recent increase in cattle prices and that is due to the recent announcement of the tariff removal for the Mexican export. This has brought competition among buyers; Guatemalan buyers, and Mexican buyers. So farmers are now starting to benefit from a slight increase in cattle prices and farmers will sell to buyers that pay them the

most," ended Garcia. She said that while slaughtering facilities would usually have their animals ready for slaughter, that doesn't appear to be the case at this point. They have reported back that due to the ongoing drought in the country some of their animals are not ready for slaughter and so they have resorted to depending on products from local farmers, who are now locked in the price war between the Mexicans and Guatemalan buyers.

Currently, Belize has a national heard of 170,000 cattle spread across the country. Experts say that the country has over 30,000 cattle that are readily available annually for local consumption and export. To date, the country has already exported a little over 12,000 animals, which is not even half the amount that is intended for export. Currently, an additional 15,000 to 20,000 cattle stand ready to be potentially exported out of the country.

CDC's places Belize at Level 3 Travel Warning

The Center for Disease Control and Prevention (CDC), announced this week that due

is after the CDC overhauled its rating system for assessing COVID-19 risk for travelers in April of this year. Level 2 is now considered "moderate" risk while Level 1 is considered "low" risk.

Level 4, which is now the highest rank on the CDC's measuring stick is now reserved only for special circumstances where high case counts exist, there is the emergence of new variants of concerns, and there is fear that the healthcare infrastructure is collapsing. The CDC via their notice asked travelers to ensure that they are up to date with their vaccines, prior to leaving for Belize. If they are not the CDC is asking them to avoid travelling to the country. The CDC also informed travelers that even if they are updated with their vaccine, when in Belize they may still be at risk of

getting and spreading COVID-19. They further asked that anyone two years and older should wear a well-fitted mask in indoor spaces. They ended off by asking travelers to follow all requirements and recommendations that are currently in place in Belize.

According to the CDC website Level 3, applies to countries that are recording more than 100 cases per day per 100,000 residents in the past 28 days. Belize was among five other Countries such as the Bahamas, Eswatini, Montserrat and Saint Vincent and the Grenadines that were moved on to the "high" risk column. Last week, health experts in Belize confirmed the existence of the BA.2 variant in the country, which had accounted for 93% of the samples that were taken. For this week daily positivity rate has been fluctuating between 9 and 14%.

How Grab Life will add life to the Belizean experience

During the Belize Tourism Board's (BTB) Building On Our Momentum (BOOM) Forum, representatives from BTB's partner agencies shared promising initiatives to enhance how tourists interact with and experience Belize and Belizean culture.

One such initiative is Grab Life 2.0, which, as detailed by the Zimmerman Agency's Chief Creative Director Liz Paradise, aims "to position Belize as an adventurer's paradise and in the process of doing that, de-position other places – [as] it is our goal to make them look boring."

During Paradise's presentation, much emphasis was placed on the new ads that were made to provide a glimpse of what it's like to be in Belize and "in the moment."

However, she noted, "When you have a brand idea like Grab Life, one of the big things you want to make sure it does is live beyond just the everyday advertising and live out in the world in some experiential way."

An idea that Paradise pitched follows the BTB releasing its own marine life inspired Non-Fungible Token (NFT) collection. "Imagine we partnered with a famous artist to create a collection of [for instance] 10,000 unique pieces of marine life art; then have the BTB drop the collection on 'OpenSea' or 'Rare. com'. People will pay for these images [and that money could be used] to protect the reef and other protected areas."

NFTs are digital assets created to track

ownership of a virtual item using blockchain technology. Such unique items could be artwork or sports trading cards. Each NFT is unique and can't be replicated and accrues value independently, stored in digital wallets as collectors' items.

Looking abroad, companies worldwide have been capitalizing on this emerging digital market. For example, Nike, the prominent American shoe manufacturing brand, launched its first collection of shoes known as CryptoKicks, which is being auctioned off as an NFT on the online marketplace OpenSea.

As reported by CBSNews, customers are paying between \$4,000 and \$9,500 in crypto-currency for the shoes, but some pairs have sold for well over six figures. Nearly 9,000 of the Nike Dunk Genesis NFTs have been sold, according to OpenSea.

Paradise further stressed that "the truth of the matter is young adventurous people are getting into things like this. It is the new wave. The new form of art and it is a way also to experience culture," adding that web 3.0 would provide us with the opportunity to have visitors experience Belize "in deeper ways than you can on web 2.0."

Grab Life 2.0 opens the door to the myriad of ways Belize can "activate what's next in a way that is incredibly authentic to Belize" by utilizing the most current cultural phenomena.

Belize Participates in the Green Climate Fund Technical Dialogue with the Caribbean

Green h e Climate Fund (GCF) held its 32nd Board of Governors meeting in Antigua and Barbuda, which saw Belize being represented by Director Carlos Pol and Leroy Martinez an Economist from the Climate Finance Unit (CFU) in the Ministry of Economic Development.

The four-day event brought together National Designated Authorities (NDA), Direct Access Entities (DAE), other funding agencies, and GCF stakeholders discuss the to prioritization of accessing and mobilizing climate finance a n d technical assistance for transformative

projects that will facilitate the transition to a lowcarbon and more climate-resilient Caribbean region.

The event also allowed for the CFU representatives to hold bilateral meetings with highlevel officials from the GCF, the Caribbean Community Climate Change Centre (CCCCC),t h e Central American Bank for Economic Integration, Global Environmental Fund, and other NDAs and DAEs to discuss projects in the pipeline and accreditation of national entities such as the Belize Social Investment Fund and the Ministry Economic o f Development. The event presented

an opportunity for participants to understand better what the GCF acknowledges as "climate rationale" to enhance the quality of their projects and programs. The meeting also examined the various approaches to create a climate rationale and identify the support needed for NDAs and Accredited Entities to include this component in any project or program.

Speaking at the ceremony, Director Pol noted that "[The] partnership among SIDS serves as the right platform to present a Caribbean perspective to the GCF on the actual needs of our vulnerable countries. In addition, having key players in one setting allows for better cooperation

and collaboration."

Pol, on behalf of the CEO in the Ministry o f Economic Development and NDA for the GCF, Osmond Martinez, thanked the GCF and the Government of Antigua and Barbuda for the invitation and excellent hospitality and further reiterated GOB's commitments to developing a climate-resilient Belize.

MOHW to begin immunizing children 5-11 years

The Ministry of Health and Wellness is about to begin rolling out its national child immunization program for children of ages 5 to 11 years old. Immunologist Dr Natalia Largaespada -Beer and COVID-19 survivor, paediatrician Dr Cecilio Eck, explained the details of the program at a media breakfast at the Radisson Fort George hotel in Belize City on Thursday morning, May 26.

MOHW will receive its first shipment of 124,800 doses of the new Pfizer paediatric vaccine especially suitable for young children on Saturday, May 28. The shipment is a gift from the Government of Slovakia; the vaccines are valued at USD\$20.78 per dose!

Population census numbers for 2021 from the Statistics Institute of Belize indicate this target population is 73,013 children, most of whom are enrolled in schools, so the Ministry will begin inoculation schoolchildren with the full support and cooperation of the Ministry of Education. Most of these children, 19,757 live in the Cayo, 19,615 in the Belize district and 8,754 in the Orange Walk district. Another 8,652 live in the Stann Creek district, 8,322 in Toledo and 8,019 in Corozal.

The plan is to begin vaccinating schoolchildren on Monday, May 30. The immunization program recognizes children's rights to good health and to be protected against disease. Parental consent will still be required, so the ministry has begun a public education campaign to inform parents and expand their awareness of the advantages of having their child vaccinated. The children will each need to present a signed consent form

from their parent or guardian, before they may receive the vaccine.

This vaccination program will closely parallel the ongoing i m m u n i z a t i o n program which the Ministry of Health began in 2016, to vaccinate 10-year old girls and boys against the human papiloma virus (HPV), which causes cervical cancer.

The technology used to formulate this new paediatric vaccine is by messenger Ribonucleic Acid (mRNA), with a individual dosage of 10 micrograms diluted in a 0.9 percent saline solution, for 0.2 milliliters of vaccine per inoculation. This infant-compatible vaccine is identifiable by the orange cap on the phials or bottles. Prior to this, the Ministry only had vaccines suitable for children 12 years of age or older.

There remains about a month to the school year, so the Ministry

compromised.

The Ministry will also publish hotline numbers to call in the event that a child suffers and adverse reaction to the vaccine. They may experience local reactions around the injection site such as pain, redness and swelling. They may also experience more generalized reactions like tiredness, headache, muscle pain, chills, fever or nausea.

The ministry is recommending that all children 5 to 11 years old get vaccinated, as unvaccinated persons are 24 times more likely to die when they become infected with COVID-19, and even partially vaccinated rate of fully vaccinated persons

There will also be fixed vaccination centers at all hospitals and polyclinics throughout the country. These include: Corozal Community Hospital, Northern Regional Hospital, Former Nursing School -Belize City, Matron Roberts Polyclinic, Dr Otto Rodriguez Polyclinic, Caye Caulker Health Center, Belmopan Civic Center, San Ignacio Community Hospital, K & K Guerra Polyclinic, Bullet Tree Health Center, Dangriga Polyclinic, Independence Polyclinic, Punta Gorda Community Hospital and the Isabel Palma Polyclinic.

US Baby Formula shortage unlikely to affect Belize



b b o t t A Nutrition, one of the largest infant formula manufacturers, has reportedly seen significant underproduction due to one of its factories being scrutinized by both the FDA and CDC - which has led to a shortage of Similac baby formula in the US that doesn't seem to be affecting Belize.

Supplies of baby formula first started to experience constrictions across the US in the early stages of the pandemic as a result of panic buying and supply chain challenges; however, the problems were exacerbated when in February, Abbott Nutrition recalled several significant brands of powdered formula and shut down its Sturgis, Michigan, factory when federal officials began investigating four babies who suffered bacterial infections after consuming formula from the facility.

Abbott is one of only a handful of companies that produce the vast majority of the US formula supply, so their recall wiped out a large market segment.

While Abbott's production of their Similac products has been significantly slowed, other manufacturers have


INFANT FORMULA

While Similac is hard to come by on shelves in the US, in Belize, major stores across the country carry an assortment of baby formulas by Nestle, Mead Johnson as well as Abbott Nutrition.

R e g i o n a l l y, the Supermarket Association of Trinidad and Tobago (SATT) recently assured the public that there is no shortage and will not likely be unless the global supply chain experience dramatic changes.

Notably, Mead Johnson, which produces Enfamil at three locations in the US, now represents half the US formula market, up from roughly a third before the shortages began.

Överall, Caribbean governments see the


Exports drop 13.2%, trade deficit widens - SIB

Delize's trade Bdeficit grew 82 percent from April 2021 to April 2022 as exports shrunk by 13.6 percent to \$39.2 million while imports grew by 53.3 percent to \$223.5 million in April 2022, \$8.2 million more than the \$152.3 million imported in April last year, the Statistics Institute of Belize (SIB) reported on Wednesday, May 25.

Higher world prices on fuel and lubricants in April this year, led to a \$54.7 million cost for imported fuels, 150 percent more than the \$21.5 million imported in April 2021. Our imports of food processing machinery and aviation equipment almost doubled to \$56.2 million, which was \$26.8 million more than the \$29.4 million imported in 2021. Imported wheat, baking powder and seed corn increased from \$20.2 million in April 2021 to \$26.7 million this April.

Other manufactured imports of truck tires, galvalume steel coils, and face masks increased by \$6.4 million, to \$29.9 million this year. Commercial Free Zone imports such as perfumes, slippers and processed cheeses increased by \$5.9 million in April, from \$15.4 million last year to over \$21.3 million this April. Other imported manufactured items such as beer, plastic bottles and air quality monitors increased from \$8.6 million last year to \$12.5 million this April. Imports of whiskey, wine and cigarettes fell from \$9 million in April last year to \$5.7 million this year. Considering the first four months of the year, the agglomerated imports were valued at \$856.2 million which was 43 percent for than the \$598.7 million imported in the first four months of 2021. Fuels and lubricants almost doubled from \$73.3 million last to \$141.9 million so far this year. Imported machinery and transport equipment also cost 61 percent more - \$177.1 million, compared to \$109.8



million imported in the first four months last year. Commercial Free Zone imports of tennis shoes, cigarettes, and bags also grew by \$55.3, from \$75.9 million last year. Belize bought \$23.8 million more fertilizer in the first four months this year - \$88.2 million worth, compared to \$64.4 million last year. Food imports in this 4-month period increased from \$75.7 million to \$92.5 million, primarily for wheat, canned meats, and salted pigtails.

Belizeans imported \$22.1 million more of tubes, cement clinkers, and galvalume steel coils: \$119.3 million in these first four months compared to \$97.2 million last year. Belize also bought more medical supplies, beer cartons and plastic bottles, which increased from \$45 million last year to \$56.4 million this year. Imports of disassembled drums, European oak and shrimp feed for designated processing areas increased to \$14.7 million this year compared to \$10.4 million last year. Cooking oil imports also grew from \$7.1 million for the beginning of last year to \$9.5 million this year. Belize's exports in April fell far short of the value of imports. Sugar exports earned \$6.5 million, down from \$23.8 million last year, as no bulk sugar was shipped this April of this year, compared to two shipments last year. Banana exports also fell to \$7.3 million \$ this April, compared to la

\$9.1 million in April last year. Similarly

in April pepper sauce exports milarly fell to \$800,000 from \$1 million last year.

Fortunately, molasses exports grew by \$4.7 million, from a measly \$30,000 last year. Lobster tails and lobster meat fetched better prices this year, causing marine product exports to grow from \$2.1 million in April 2021 to \$3.5 million this April. More exports of orange and grapefruit concentrate, earned \$1 million more, up from \$2.7 million last year. Red kidney bean exports grew to \$1.7 million, a \$700,000 increase over last year. Exported crude oil increased in value to \$200,000 this April, compared to a mere \$40,000 exported in April last year.


Inflation 5.8% in Cost of Living - SIB

The cost of living has gone up 5.8 percent in April 2022, compared to 2021, driven by higher fuel and food prices, the Statistics Institute of Belize (SIB) reported on Wednesday, May 25.

The Institute compiles the prices Belizeans normally pay for fuel, food, drinks, utilities and housing into the Consumer Price Index (CPI), which went up 5.8 percent from 103.0 in April 2021 to 108.9 for April 2022.

Transportation costs increased 16.8 percent up for April 2022, compared to last year, as vehicle fuels went up 25 percent, with diesel up 35 percent! Diesel went up by \$3.54 per gallon, from \$9.99 last year to \$13.53 this April. Premium gas increased by \$2.69, from \$11.73



to \$14.42, and regular gasoline went up by \$2.81 from \$10.77 to \$13.58. The price on a new car went up 8.1 percent and bus fares increased 5.6 percent. Butane also went up

This cost went from \$115.66 last year to \$149.59 this April.

Food and beverages prices went up 7.1 percent over last year, with tomatoes more than doubling in price from \$1.24 per pound to \$2.78, a 124.6 percent hike! Cabbages went up 72.6 percent, from \$1.19 to \$2.06 per pound. Pigtail prices jumped up 56.4 percent to \$7.55 per pound, up from \$4.83. Vegetable oil went up by 36.8 percent to \$4.82 per liter, and coconut oil by 17.7 percent to \$14.92 per liter. Irish potatoes went up 38.1 percent, from \$1.73 to \$2.38 per pound. Rice increased 10.7 percent from \$1.37 to \$1.52

per pound, while whole chicken went up by 3.5 percent to $\frac{2.98}{lb}$. Watermelons went up 26.8 percent to 78 cents/ pound, flour by 5.5 percent and pineapples by 6.1 percent. Fresh fruits like oranges were slightly cheaper, by 1.6 percent, and red kidney beans came down 4.4 percent to \$1.98/lb, and black beans were 4.5 percent cheaper at \$2.02/lb.

H o u s e h o l d maintenance costs went up 2.9 percent, mainly due to higher prices on cooking fuel, while construction materials for household maintenance went up 14.2 percent. Rent and utility rates fell off slightly by 3.5 percent for electricity. Laundry soaps and detergents increased 7.2 percent. Restaurant and accommodation rates went up 5.1 percent. Clothing and shoes for women went up 2.9 percent, but information and communications costs came down one percent.

Orange Walk Town is still the most expensive place to live with a 9.4 percent inflation rate as food prices, detergents, soaps and home rental costs all went up. Belize City was second with 6.0 percent inflation, and Corozal - 5.8 percent inflation. Benque Viejo cost of living increased 5.7 percent and Independence -5.6percent and Dangriga 5.4 percent. Punta Gorda Town saw a 5.2 percent increase. San Pedro Town reported the lowest inflation rate of 4.2 percent.


NOAA predicts abnormal Atlantic Hurricane Season

Forecasters at National Oceanic and Atmospheric Administration (NOAA) are predicting aboveaverage hurricane activity this year, which would make it the seventh consecutive aboveaverage hurricane season.

For the 2022 hurricane season, NOAA is forecasting 14 to 21 named storms, of which six to 10 could become hurricanes, including three to six major hurricanes.

This hurricane season's increased activity is attributed to several climate factors, including



the ongoing La Niña that is likely to persist throughout the hurricane season, w a r m e r - t h a n average sea surface temperatures in the Atlantic Ocean and the Caribbean Sea, weaker tropical Atlantic trade winds, and an enhanced west African monsoon. NOAA emphasized that an enhanced west African monsoon supports stronger African Easterly Waves, seeding many of the strongest and longest-lived hurricanes during most seasons.

Last year, NOAA

updated its definition of a typical hurricane season to reflect the new normal of climate change. It now considers hurricane seasons that are "above-average" to have more than 14 named tropical storms instead of 12.

M a t t h e w

Rosencrans, NOAA's leading hurricane season outlook forecaster, cited that "There are certain ingredients that drive the intensity and frequency of hurricanes, including how much dust is in the air, how windy it is, and how warm the water on the surface of the ocean is."

Unfortunately, humankind has no control over some of those ingredients and are thus unrelated to human-caused global climate change. For example, the natural climate variation known as La Niña has been happening for multiple years, and it drives ocean and wind conditions that support the formation of tropical storms in the Atlantic.

However, though we might not have control over those natural phenomena, certain actions can be done to curb climate change, thereby, removing the possibility of intense storms forming due to hotter ocean water and hotter air, which create perfect conditions for hurricanes to construct, enlarge and cause devastation to countries that are already under sea level.

NOAA further stressed that though the outlook simulates the number of anticipated storms that would have the potential to form, it is not simulating that all of them will make landfall.

Libertad villager charged with murder following fatal machete attack on his host

Corozal Police have moved swiftly to arrest and charge a man who is suspected of hacking a resident of Concepcion Corozal to death and allegedly chopping the victim's cousin several times to her face.

On Tuesday, May 24th, police announced that a single charge of murder was leveled against 36-year-old Jermain Dion Zuniga, a Belizean construction worker of Libertad Village, in relation to the death of Juan Mendez, 47.

While authorities did not provide information as to whether Zuniga will be charged for the horrific injuries he caused to Mendez's cousin Wendy Mendez, 34, they say that their investigation into the incident remains ongoing.

Neighbors living in the village reported that just after midday on Sunday, May 22nd they heard screams coming from inside a cement bungalow house in the neighborhood. While the screams intensified, the neighbors said that they heard a group of people cursing at each other while the sound of a machete being scraped and lashed against the concrete wall drowned out the voices. After about half an hour, there was silence, and the residents say that they saw a dark complexion male person emerge from the house, and rode off on a bicycle. Shortly after, according to the neighbour's accounts, the man returned, went back into the house and emerged a second time. This time he walked to a pipe that was situated inside the yard, stooped down and washed what appeared to be bloodstains from off of his face, and hands before jumping on his bike and riding off once more. The neighbors said that they waited for family members to arrive first and when

they went inside the house they found Mendez, lying face down on the ground already dead with multiple chop wounds to his back, shoulders and neck. Nearby on a bed, they found Mendez's cousin Wendy Mendez laying on her stomach, partially nude and bleeding profusely from multiple chop wounds to the face. Police were called out to the scene where they confirm that Mendez was dead while Wendy was alive but unconscious. She was immediately transported to the Corozal Community Hospital and then to the Northern Regional Hospital where she remains fighting for her life. An investigation launched by the police revealed that Mendez had reportedly offered Zuniga lodging at his house, but while socializing, Zuniga had reportedly attempted to force himself onto Wendy which prompted Mendez to request that he leave the residence. Zuniga, police say did not respond well to Mendez's request and he reacted by pulling out a machete and chopping Mendez several times to his body before turning the machete on Wendy who he sliced several times to her face. Residence says that when police were processing the scene, Zuniga returned, with the machete strapped on his bicycle and joined the group of spectators, even asking at one point what had occurred inside the house. That is where he was identified and immediately detained by police and taken into custody for questioning.

According to reports, three men, disguised as police officers carrying handguns and handcuffs, entered the home of Esther Crispia. The pretend



MoHW issues Recall for Jif Peanut Butter Products

The Ministry of Health and Wellness advised that the J.M. Smucker Company voluntarily recalled select Jif Peanut Butter products due to potential Salmonella contamination.

MoHW has since commenced a thorough investigation at major supermarkets countrywide as a precautionary action as Belize imports the product in question.

Senior Public Health Inspector Lisa Marin confirmed that while persons internationally who ate it contracted salmonella, "so far we haven't received any such information of people being ill from the Jif Peanut Butter [here in Belize]."

Healthy persons infected with salmonella often experience fever, diarrhea (which may be bloody), nausea, vomiting, and abdominal pain.

The Ministry further cited a list of recalled products along with lot codes 1274425 – 2140425, which are included alongside the best-if-used-by date.

Marin advised the public that in "the event they have a product with these lot numbers and the UPC number - contact the nearest public health inspector office or the Ministry of Health at 8285257 so that we can assist you as best as possible in removing this product from the market."

The FDA reported that it collected an environmental sample containing a strain of salmonella at Smuckers' Lexington, Kentucky facility in 2010 and that genetic analysis has determined that the strain of salmonella connected to this outbreak matches that previously collected sample. "Epidemiologic evidence indicates that Jif Brand Peanut Butter produced in the J.M. Smucker Company facility located in Lexington, KY, is the

officers claimed that they were conducting a search.

P o l i c e Communications Officer ASP Fitzroy Yearwood explained that Crispia reported that she was at home when three men dressed in military attire arrived at her residence.

The men then identified themselves to be police officers and instructed Crispia to comply as they were there to search for narcotics and illegal ammunition.

Upon complying with the pretend officers, they escorted her to her bedroom, where they "found" a crocus bag stuffed with more than BZ\$130,000 in Belize and U.S. currency. Crispia was then informed that the discovered crocus bag would be confiscated and taken to the nearest police station as it is suspected the money was generated from "the sales of illegal drugs."

The men, thereafter, exited Crispia's residence, escaping in a white pickup truck.

A f t e r m u c h contemplation, Crispia then concluded that the "officers" were, in fact, crooks disguised as personnel from the police department. This prompted her to file a report.

During the press conference, ASP Yearwood further advised the public that police officers are expected to have their police-issued IDs available to prove that they are legitimate lawmen and lawwomen.

"They have their name tags that were issued. So if the police come to your house not displaying or showing you their ID card, then you know that they are not police officers," said Yearwood.

ASP Yearwood further detailed that the recently issued IDs are "signed by the Commissioner of Police, Chester Williams. It [also] has the officer's personal information on it, down to the date of enlistment and the date of birth."

As of this report, the police are looking for two persons known to be involved in crimes of this nature.

'Running W' to skip National Agriculture and Trade Show

The National Agriculture and Trade Show (NATS) 2022 is set to kick off this weekend and one major company whose name is almost synonymous with the weekend festivities, Running W Brand Meats, says it's not going.

On Monday, May 24th the Company via a short press release informed the public that unfortunately, they would not be attending NATS 2022. "This is due to the current short supply locally of Beef and Pork, and the rise in Covid Cases," the company stated.

Following their announcement, several social media fans expressed their



disappointment at the last-minute changes. The majority of them stated that over the years Running W's free samples of its big-bone pork chops, baby back ribs, and free sample of sausages and other meat delicacies, are the main reason why they

have been returning almost every year to the grounds.

"We are disappointed that we cannot be there this year, but we want to thank our valued customers for your continued support," said the company.

A deeper check into

the situation revealed that there is not necessarily a shortage of beef or pork in the country, instead, there is an ongoing price war at play.

In this situation, Principal Agriculture Officer and

Director of Livestock in the Ministry of Agriculture, Food Security and Enterprise Belarmino Esquivel says that it is more a matter of supply. He explained that while the export market is offering cattle farmers up to \$2.40 per pound, local buyers are paying less.

Currently, according to Esquivel, the cattle export business is booming as both Guatemalan and Mexican buyers are offering a higher price to cattle producers when compared to what local Belizean buyers are offering. It, therefore, comes as no surprise, said Esquivel, that the cattle producers will want to sell their products to anyone who offers them a better deal.

That, however, while a good thing for the cattle producers, spells trouble for the local meat processing companies, who are now forced to compete with the high prices for meats which on a daily basis keep fluctuating, even while they are striving to meet profits and overhead cost.

That is where Running W Meats Escander Bedran, owner and manager, says that the company finds itself. That situation is compounded further by the effects of the ongoing dry season on cattle, leading to a shortage of cattle that are ready for slaughter.

Bedran explained that it is because of these factors that the company decided not to attend the National Agriculture and Trade Show. Apart from incurring a loss, he would only be risking the health of his employees at the event amid the rising COVID cases.



People can also do their part to reduce risk to their safety by remaining calm, not trying to escape or run, resist, or obstruct the officer. Lying is also a bad idea as providing false information or documents to the police can result in a criminal charge. Additionally, you must always keep your hands where the police can see

The Trade License Regime: A 'tax' by any other name (Part 2)

In the immediately preceding Business Perspective (BP) Column entry, we had delineated the distinction between a "tax" and a "fee." More precisely, we had looked at the fact the trade license regime (TLR)—which is based on a percentage of a business's annual rental value (ARV)—functions much more akin to a property tax than the "fee" it proposes to be. And as far as "fees" are concerned, we had underscored that TLR breaches several international best practice principles.

For those reasons and more, the Belize Chamber of Commerce & Industry (BCCI) had to take a mixed position when it comes to the Trade Licensing Bill 2022 ("the Bill") that was tabled before the National Assembly recently. On Monday, May 23, the BCCI presented its position to the Public Service, Labour, Industry, and Trade Standing Committee ("The Committee"). Fundamentally, our position can be divided into two general categorize: The Short-to-Medium Term and the (Medium to) long term.

Revenue Neutrality & The Short-to-Medium Term

Let's begin with the short-term. As the BCCI communicated to The Committee, our position has been one of "compromise with the local government's need to preserve a center level of revenue." This compromise, however, has been limited to only the nine municipalities that currently rely on trade license regime. It is for this reason that the reform process—again, which dates back to at least a decade—has revolved around five principles: *Revenue-Neutrality, Predictability, Accountability, Administrative Ease, and Transparency.*

Most of the other four principles are somewhat self-explanatory, but *Revenue Neutrality* demands some special attention.

Let's start here. Across the nine municipalities, the regime generates approximately \$9 million, with Belize City accounting for almost 60% of that amount. The balance is split among the remaining eight localities; namely, Belmopan City, Corozal and Orange Walk towns, Punta Gorda, Benque, Dangriga, Santa Elena/San Ignacio, and San Pedro.

For Belize City, as we discussed last week, the revenue from trade license represents approximately 20% of CITCO's total income. The other municipalities have likewise—although to varying degrees—come to rely on this source of cash in order to carry out their function. As a result, it would be deemed irresponsible for the business community to advocate for the complete and immediate eradication of the regime, even though—as we've previously highlighted—the trade license's design deviates from international best practice. To that end, we have worked along with the Ministry's proposal for a new, ARV-based methodology that would satisfy all five principles mentioned above. For this reason, we had accepted that-IN THE SHORT-TO-MEDIUM TERMadherence to revenue-neutrality would essentially entail preserving the property-tax-like design of the trade license regime, with the understanding that it is gradually phased out.

place. One company, for instance, would have seen its current fee jump from less than \$1500 to more than \$30,000—a more than 3,000% hike. Try to imagine that is supposedly a "fee" for just starting and operating a business.

Observing these vast increases, the BCCI—during our consultations with GOB—had advocated for a "ceiling". The Government, to its credit, agreed, and ultimately chose to implement a 10% ceiling, which is captured in section 53 of The Bill.

Of course, the government, in an effort to preserve the local authorities' revenues, also put forward a "floor." Consequently, a company that is paying, for example, \$20,000 in trade license tax, and would have otherwise been reduced to \$10,000, would only be allowed to save \$2,000. The new tax—with the floor in place—would be \$18,000.


Clearly, this is an imperfect system. However, it was one that the BCCI was ready to work along with in the short term, on the condition that the government incrementally TRANSITIONED towards a flat fee with the next five to ten (or even 15) years. This was consistent with the Revenue-Neutrality principle. This transition phase was to allow the local authorities the time to identify alternative sources of income, so as to become less reliant on a system that is in clear breach of international best practice.

Regimes' Expansion to Villages Breaches 'Revenue-Neutrality'

With the above in mind, then it should become easier as to why certain parts of the Bill were met with far less support from the BCCI. Predominantly, those offending areas violated revenue-neutrality which the parties to this reform process had initially agreed to.

Remember what we said. We opted to compromise with a dysfunctional system in the municipalities that already had the regime, because those nine local governments had already become dependent

on the trade license revenues. The idea was to wean them off this cash cow over a period of time, acknowledging that that time period may span several years.

Therefore, the idea to export the already dysfunctional regime to the villages could not be countenanced, and benefited from absolutely no support from the BCCI when it came to businesses with square footage ABOVE 1,000 square feet. Of course, this requires some elaboration.

Let's start here. Section 2 of the Bill expands the definition of "licensing district" to include "the limits of each village as defined under the Village Councils Act." Despite repeated objections to this concept when it was presented to us during the consultations, this change still found its way into the Bill.

Section 21 of the Bill creates certain agreeable carve outs. Businesses located in the villages with

area below 600 sqft would be exempt. That's fine. Firms with square footage between 600 and 800 sqft would be charged a flat-fee of \$100. That's also fine, as that's a flat-fee. Businesses between 800 sqft and 1,000 sqft, would be charged a flat fee of \$250; this is also okay.

The problem enters when the businesses have an area greater than 1,000 sqft. The Ministry's idea is that companies located in the rural areas with square feet GREATER than 1,000 sqft would fall under the same Annual Rental Value (ARV) system that currently exists in Belize City and the other eight municipalities.

If the only reason (the only reason) the existing dysfunctional system was largely being preserved in the nine municipalities was due to revenue-centric reasons, how then can there be any justification for expanding it to areas where it previously did not exist? And if the goal is to transition us away from that ARV-based system over time, why, then, would it be acceptable for the same system to be

exported to the rural areas? That is the very opposite of phasing something out, or moving towards best practice.

Furthermore, it offends revenue-neutrality because the would-be expanded regime would now surpass the earlier mentioned \$9 million in takings from the regime. Even the more acceptable flat-fee approach for rural-area businesses below the 1,000 sqft threshold would offend revenue-neutrality, but at least that would have been an actual fee, as opposed to a property-tax by another name.

Of course, some stakeholders would argue that it best to expand the ARV-based regime to the villages to, as the saying goes, "equal the playing field," especially when the villages in question are contiguous to cities or towns. The operative question, here, is this: If the goal is to eventually phase out the licensing regime, why would it be deemed appropriate to expand it to even those contiguous localities. The risk, here, would be getting the villages accustomed to a certain revenue source only to eventually try and remove it in the future.

But, most importantly, the Trade Licensing Bill did not limit itself to villages contiguous to urban areas such as in the case of Ladyville bordering Belize City. Instead, the Bill targeted all villages throughout the entire country.

Furthermore, how can it be deemed as "equalizing the playing field" between businesses in the rural and urban areas? Cities and towns—especially Belize City—enjoy greater infrastructure and access to consumers than do their less developed village counterparts.

For example, when discussing potential consumer base, going by the 2010 census, Belize City had a population of 57,169, while Crooked Tree had only 805. Double Head Cabbage had 406 residents. Ladyville had 5,458, and Hattieville was reported at 2,344. Clearly, a lot has changed in 12 years, but the ongoing census is needed to confirm exactly the nature of those changes. However, if things remain relative—and they most likely will—then idea of "equality" may need to make way for "equity."

On a final note, there is also a public policy consideration that should be weighed. Yes, it is true that some businesses do leave the urban areas for the villages. And, of course, the revenue-centric paradigm leads the local authorities to view this departure as "bad for council business".

Consequently, to "stop" or "slowdown" this migration of economic activity from urban areas to the villages, the councils consider the regime's expansion as being necessary. However, this is somewhat contradictory from a rural development standpoint, as one would think that the default economic-public-policy position would be to encourage increased economic activities in otherwise poor communities.

PRESS RELEASE Cabinet Brief

Belmopan. 26th May 2022. 9:00 a.m.

The Cabinet, chaired by the Prime Minister Hon. John Briceño, met in regular session on 24th May 2022.

- The Minister of Blue Economy and Civil Aviation informed Cabinet of a constructive meeting with the leaders of communities in southern Belize to address the issue of erosion on Silk Caye. After meeting with relevant stakeholders, a task force was established including the leaders of communities in southern Belize, technical advisors from the Ministry of Blue Economy and Civil Aviation, Ministry of Natural Resources, Petroleum and Mining, Ministry of Sustainable Development, Climate Change and Disaster Risk Management, and the Belize Coast Guard. Based on the findings of the assessment, the Fisheries Department will be giving approval for the community to proceed with the work started to address the erosion with the support of the technical experts.
- Cabinet noted that at Monday's House Committee meeting, stakeholders presented their concerns regarding the Trade License Bill 2022. Noting the fragile state of the entertainment industry caused by the COVID-19 pandemic, Cabinet agreed to defer any fee for local entertainers while consultations continue with stakeholders in the entertainment industry. In addition, Cabinet will consult to develop incentives for the creative sector. All other recommendations presented at Monday's House Committee Meeting will be duly considered before the revised bill is presented to the House of Representatives for consideration.
- Cabinet gave its recommendation for a motion to be presented at the next sitting of the National Assembly for a loan motion from the Central American Bank for Economic Integration (CABEI) for US\$24 million to finance the upgrading and rehabilitation of 16 miles of the Phillip Goldson Highway, from mile 8 1/2 to 241/2. The rehabilitation of this 16-mile section of the Phillip Goldson Highway is expected to reduce transportation costs and accident rates, increase access to services, increase employment opportunities and improve climate resilience.
- With a view to fast-track private sector investment and further stimulate economic growth, Cabinet approved certain policy and legislative adjustments to reduce turn-around time and streamline processes and provide additional incentives for various investment incentives programs including the small business (MSME) enhancement program, the designated processing areas program used by BPO's, agro-processing, aquaculture and manufacturing, and the fiscal incentives program used by tourism and other business ventures.
- Cabinet approved the development concept of a Government Administration Campus in Belize City in the Lake Independence Development Area using a public-private partnership vehicle. It is intended that such a campus will consolidate government departments scattered across the city including the various courts of the judiciary and enable the more efficient provision of government services to the public.
- Cabinet took note of the report from the Inter-Ministerial Committee on measures that would improve the effectiveness of garbage disposal as well as recommendations on the sustainable practices to promote a clean environment, climate protection and zero waste for the health, aesthetics and well-being of the country. Recommendations include a review of the current environmental



protection regulations, amendments to the Returnable Containers Act, strengthening the institutional capacity of the Department of the Environment, and new actions on plastic and waste disposal and an awareness campaign on cleaner communities and on recycling.

- On COVIS-19, As of 23rd May 2022, 216,474 or 50.32% of the total population have received at least one dose of the vaccine, 211,693 or 49.21% of the total population two doses and 47,671 or 11.09% of the total population had received booster shots. As of 23rd May 2022, 31,803 or 54.56% of the target population (58,292) of children ages 12 to 17 years have received at least one dose of the vaccine and 26,628 or 45.68% of the target population have been fully vaccinated. Since the start of the pandemic, the cumulative number of deaths up to 20th May 2022 is 677.

Healthy snack ideas to keep you feeling full

I fyou're looking to improve your snacking habits, these 14 healthy snack ideas can help you to boost your energy levels, and even help with weight loss.

Snacks can be an important part of a healthy diet. But so much depends on what you reach for at that moment when your stomach growls with hunger, or you experience a dip

in your energy levels. Opting for a healthy snack, like one of the best protein bars, as opposed to fast food, candy, or a salty snack, can affect your weight, and your overall health.

This article takes a closer look at whether snacks can be a healthy option between meals, whether morning or evening snacks are better, and what healthy options you can build into your overall eating patterns to get the most from your snacks. Plus, we speak to a registered nutritionist to get the lowdown on what and when to eat.

New statistics gathered during the coronavirus pandemic found

that working from home accelerated snack consumption even further.

Snacking between meals can give you a much-needed energy boost. It can also help to control your blood glucose levels, and curb your appetite to avoid overeating during main meals. They can also be a source of extra nutrients or calories if you find it hard to schedule, or finish, a main meal.

Registered nutritionist for ProYouth Nutrition, Rachel Akuffo agrees. "Small snacking that consists of healthy choices may be helpful to keep your energy levels up and could prevent you from becoming overly hungry and overeating at your next meal," she says.

But she adds a word of warning: "Ultimately it's about calories consumed versus calories expended. Whether snacking is beneficial or not depends on why you are snacking, the snack choices, and how much."

As we all know, poor snacking choices, or too many snacks, can reduce how hungry we feel at mealtimes, leading us to skip out on essential nutrition, changing our eating behaviors for the worse, and increasing our urge to eat salty, sugary, or fatty foods that are detrimental to our health. Bad habits can stick too, as Akuffo points out: "If you are simply responding to snacking habits, brain simulation of temptation by chocolates and other unhealthy snacks, then snacking can lead to weight gain and other issues." Harvard School of Public Health says that the ideal snack should be "enough to satisfy, but not so much that it interferes with your appetite for a meal or adds too many calories". They suggest aiming for a snack that has around 150-200 calories. However, if you're trying to lose weight, the British Heart Foundation suggests cutting this to around 100 calories.

more associated with being overweight than any other snack time.

The researchers also found that midmorning snacks tended to be healthier than at any other time, and typically involved more fruit and vegetable consumption. Evening snacks were more likely to be French fries, fast food, and soft drinks. People who snacked in the evening were also more likely



to be distracted during eating, which can result in consuming more food.

A 2017 study in the American Journal of Clinical Nutrition also found that eating food during the evening and night was more likely to result in a higher body fat percentage and body mass index (BMI). The upshot? The

you have to have a snack at night, don't sweat it too much. As Akuffo says, "Whilst it's good to give your body a break at night times, if your body hasn't had adequate calories, or you are a shift worker, then your snacking pattern needs to be altered."

HEALTHY SNACK IDEAS

• A sliced apple and a tablespoon of peanut butter: Apples are a great source of fiber, vitamin C and potassium,

of fiber, vitamin C and potassium, while peanut butter is packed with protein, fiber, and vitamins and minerals.

• String cheese with whole grain crackers: String cheese contains calcium, while the wholegrain crackers will provide fiber to fill you up.

• Crunchy veg crudités such as peppers, carrots and celery, topped with a light dressing of zero-fat Greek yogurt, parsley, mint and a squeeze of lemon: Add a scattering of pine nuts for extra protein.

• Trail mix with chopped dates

or fresh fruit: Makes a satisfying snack with plenty of protein and heart-healthy fats.

• Protein bar: A protein bar can help to curb appetite. Choose one packed with natural, unprocessed sources of protein, such as nuts and yogurt.

• Air popped popcorn (2 cups): Popcorn is packed with fiber, helping to fill you up without the calories. Be sure to choose plain popcorn rather than a flavored brand.

• One cup of plain, low-fat Greek yogurt and ½ cup of fruit, such as blueberries, strawberries or apricots: Greek yogurt is an excellent source of calcium and protein, while fruit can provide a boat to your daily vitamin and fiber intake.

• Half a cup of edamame beans: These are high in protein and rich in vitamins and minerals, such as iron, magnesium, folate and vitamin K.

• Two tablespoons of cottage cheese and six cherry tomatoes on a rice or oatcake: This low-calorie cheese is high in protein and nutrients, and is often used in weight loss plans. The cherry tomatoes are packed with antioxidants, and the oat or rice cakes provide fiber. • One sliced banana on a slice of wholemeal toast: Bananas are a filling source of fiber, and antioxidants, while wholemeal bread contains iron, folate, potassium, and magnesium. • A sliced red pepper and three tablespoons of low-fat hummus: Peppers are loaded with antioxidants and low-fat hummus is rich in calcium, iron, and magnesium. • A quarter of sliced avocado on a wholegrain crispbread: Avocado is packed with healthy fats and nutrients, such as vitamin K and folate. The crispbread adds fiber, which will help you to feel fuller for longer. • A boiled egg: Eggs are an excellent source of protein, healthy fats, and vitamins, plus they're low in calories. • A small handful of mixed nuts, such as walnuts, Brazil nuts, cashews and pistachios: Eating nuts in moderation can help you lose weight, and they are a rich source of fiber, protein, and healthy fats.

WHEN IS THE BEST TIME TO SNACK?

A 2019 study into snack times in Seattle workplaces looked at the relationship between obesity and the timing of snacks. Researchers found that evening snacks were later you snack, the more likely you are to make unhealthy choices, and eat too much.

So when is the best time to snack? This seems to be harder to pin down. Much of it depends on what you reach for, as opposed to when you eat your snack. However, a 2020 study into the effects of having a low-sugar mid-afternoon snack of hummus found that it reduced subsequent snacking on sweet and sugary foods later in the evening by 20%.

Eating more food earlier in the day, rather than at night, is also good for you, say researchers. A 2019 study into the relationship between circadian rhythms and eating, found that taking in more energy early in the day reduced inflammation, improved sleep and increased the body's ability to cope with stress. It also improved gut health.

Given that we know late night eating can increase obesity, it appears that keeping your snack times to morning or afternoon is better for you, both in terms of weight loss, and overall health.

However, it's not always a choice. Working patterns and busy days can disrupt our schedules from time to time, so if you find

How the Colors Pink and Blue Became Associated With Gender



It might seem to people today that baby boys have always been gifted with blue things and little girls pink, but as with most things in life, those associations are much more modern than one might imagine.

It wasn't until after WWI that pink and blue became gender signifiers. Until then, like I mentioned, children up to the age of six or seven were usually dressed in gender neutral clothes that could be easily bleached clean, and that allowed parents to use the same clothing for any and all subsequent children.

Pastel colors like pink, blue, and yellow were introduced in the mid-1800s and were widely used, but were considered "baby and child" colors, not assigned to one sex or the other.

Then in June of 1918 Ladies Home Journal published an article that claimed, out of the blue, that "the generally accepted rule is pink for the boys, and blue for the girls."

Which is, of course, the opposite of the generally accepted rule today. At the time, pink was associated with red and considered too harsh for girls, who should be dressed in the more muted colors of sky and sunshine.

It was likely a marketing strategy to begin associating colors with sex in the first place. After all, why sell only one set of baby and toddler clothes when you could sell two?

By assigning colors to boys and girls, clothing manufacturers and retailers could double their sales, and by 1927, department stores all over America had jumped on the growing trend. Time magazine even printed a chart showing appropriate colors for each sex (though boys were still being assigned pink).

In the 1940s, the assigned colors flipped – blue for boys, pink for girls – but the popularity slowed with the advent of the women's lib movement. For awhile, unisex clothing made a comeback that remained strong until the 1980s – around the time ultrasounds became clear enough for parents-to-be-to learn their child's sex while still in the womb.



Scientists say the best way to convey sarcasm in your text messages is to use a winky face. Without it, your jokes are often completely misinterpreted.






Why the Wrinkly Fingers?

• Moose are the largest of all the deer species in the world.

Only male moose (bulls) have antlers. The particular shape differs from animal to animal and they are shed every year around November, being replaced with larger ones the forthcoming spring. The primary function of antlers is for display during the competitive mating season. • They can grow up to 1.8 m long end-to-end.

• Moose are peaceful animals which very rarely become aggressive. They will however defend themselves if threatened and males can become more highly strung during the mating season. The most common "aggressive" behaviour is however bluffing to charge, so that they remain safe without the need for combat.

• Females (cows) often give birth to twins, and even sometimes triplets. They are very attentive and protective mothers. Calves are able to browse alongside their

mothers after around 3 weeks and are weaned at about 5 months. They however stay with their mothers for at least a year.

• A male moose has a 'dewlap', a dangling flap under the chin. The size and shape of the dewlap may indicate dominance level. Males also use the dewlap to scent mark females by rubbing it against them during the mating season.

- Moose can travel at speeds up to 35mph, and can trot steadily for 32 km in just an hour.
- Despite their size and weight, moose are very adept swimmers. They are able to swim for several miles and can even be totally submerged under the water for around 30 seconds.

1. **BACKGROUND**

- 1.1 The Government of Belize, through the Ministry of Finance (MOF) is embarking towards the modernisation of the tax administration by merging the existing Income Tax Department (ITD) and the Department of General Sales Tax (DGST) into a single function- based tax administration, and procuring and implementing a new Integrated Tax Administration System (ITAS).
- In order to facilitate the process, the Tax Modernization Program was initiated and comprises 1.2 of five main projects/components including: (a) Communication and Change Management; (b) Organization/Human Resources (HR)/Infrastructure; (c) Business Processes Re-engineering; (d) Legislative Framework; and (e) Information Technology. These will be implemented in phases, with the existing core areas of the ITD and DGST operating as the new, consolidated functional organization, the Belize Tax Service (BTS).
- 1.3 To support this endeavour, the GoB has requested the support of the Inter-American Development Bank (IDB) to fund a five-year project "Strengthening of Tax Administration" (BL-L1031). The main objective of the Project is to strengthen Belize's tax administration aimed at increasing tax revenue collection, through the following specific objectives: (a) increasing the effectiveness of the Government to collect taxes, through improvement in the tax administration governance and; (b) increasing tax administration efficiency, through improvement in the operational processes and modernization of the technological infrastructure.
- A Program Management Office (PMO) supports the implementation of the Program along 1.4 with the consolidation of the BTS. The MoF is the Executing Agency (EA) of BL-L1031. For this purpose, a Project Executing Unit (PEU) will be established in the PMO with concrete technical, administrative, financial, control and planning, monitoring and evaluation responsibilities for the IDB-funded initiative.
- 1.5 In this regard, a vacancy exists for the Procurement Officer for the PEU under a contractual arrangement with the MoF, and as part of the BL-L1031 initiative.

OBJECTIVE AND SCOPE OF WORK 2.

2.1 The objective of the position is to lead the execution of the procurement activities of the PEU in accordance with the provisions of the Project and the Bank's procurement rules and procedures and the MoF procurement guidelines, when applicable.
